RESOLUTION AMENDING THE FY 2018 BUDGET TO TRANSFER FUNDS

TO THE JAMES RIVER COMMERCE CENTER OPERATING EXPENSE

- WHEREAS, the Economic Development Authority (EDA) of James City County, has been asked to pay the James River Commerce Center Annual Dues for Parcel 6 and Parcel 11, located at 1716 Endeavor Drive and 8915 Columbia Drive; and,
- WHEREAS, Parcel 6 and Parcel 11 were recently acquired by James City County; and,
- WHEREAS, the EDA had previously budgeted for the Annual Dues for the EDA-owned parcel at 8925 Columbia Drive in the James River Commerce Center Operating Expense line item; and
- WHEREAS, at the January 11, 2018 EDA meeting, the EDA reviewed a contract to perform site cleaning work; and
- WHEREAS, the EDA unanimously agreed to proceed with site cleanup of approximately 29 acres of the parcel south of Columbia Drive; and
- WHEREAS, the EDA desires to transfer \$20,000 from the Business Assistance line item to the James River Commerce Center Operating Expense line item; and
- WHEREAS, the EDA desires to transfer \$21,804 from the Newport News/Williamsburg International Airport Funding (RAISE) line item to the James River Commerce Center Operating Expense line item.
- NOW, THEREFORE, BE IT RESOLVED that the Economic Development Authority of James City County, Virginia, hereby amends the FY 2018 budget to transfer \$20,000 from the "Business Assistance" line item to "James River Commerce Center Operating Expense" line item; and
- NOW, THEREFORE, BE IT FURTHER RESOLVED that the Economic Development Authority of James City County, Virginia, hereby amends the FY 2018 budget to transfer \$21,804 from the RAISE line item to the James River Commerce Center Operating Expense line item.
