SUBJECT: Youth Advisory Council

The Youth Advisory Council was formed six years ago for the purpose of serving as a link between the youth of James City County and the government of James City County. The Council serves as a forum for the youth of the County to present their ideas, needs and suggestions and to enhance the awareness of needs, challenges, and issues affecting the youth of James City County.

The Council is comprised of 15 youth who represent a diverse population by gender, race, school, grade, and income status. Youth are required to complete an application and interview process and must have a positive reference from a teacher.

As with previous work sessions, the Council felt a work session would be a good opportunity to facilitate dialogue between the groups and allow for improved understanding of their relationship with the Board.

The Council will provide the Board with an overview of their accomplishments, their goals for the coming years, and some feedback concerning what they perceive to be pressing issues in our community. Attached are the results of the biannual survey developed and administered by the Council as part of their responsibilities. The Board may find this information useful in the upcoming discussions with the Council.




1. As a teen, do you feel that there are enough extracurricular activities to do in the community?


3. Do you use the county's transportation?

5. Would you attend this center?




6. Would you use a tutoring service if it was free?

7. Do you feel as a teen you have a sense of belonging?



recreation facilities?




9. Do you feel safe walking through your neighborhood at night?


10. Do you feel there are enough jobs for youth?





13. Do you consider money a problem when finding


things to do on the weekends?

What do you do for fun on a weekend night?




2. Is transportation a problem to get from place to place?


1. As a teen, do you feel that there are enough extracurricular activities to do in the community?


3. Do you use the county's transportation?




6. Would you use a tutoring service if it was free?


7. Do you feel as a teen you have a sense of belonging?

8. Do you feel intimidated by using the current recreation facilities?




9. Do you feel safe walking through your neighborhood at night?


10. Do you feel there are enough jobs for youth?




12. Would you take advantage of community trips out of James City County?


13. Do you consider money a problem when finding things to do on the weekends?


What do you do for fun on a weekend night?




2. Is transportation a problem to get from place to place?
