ORDINANCE NO.

AN ORDINANCE TO AMEND AND REORDAIN CHAPTER 2, ADMINISTRATION, OF THE CODE OF THE COUNTY OF JAMES CITY, VIRGINIA, BY AMENDING ARTICLE II, MAGISTERIAL DISTRICT, ELECTION DISTRICTS AND ELECTION PRECINCTS, BY AMENDING SECTION 2-3, DESIGNATION AND POPULATION OF ELECTION DISTRICTS.

BE IT ORDAINED by the Board of Supervisors of the County of James City, Virginia, that Chapter 2, Administration, is hereby amended and reordained by amending Section 2-3, Designation, population and election cycle of districts.

Chapter 2. Administration

Article II. Magisterial District, Election Districts and Election Precincts

Sec. 2-3. Designation, and population, of and election cycle of districts.

(a) The election districts with populations set forth are as follows:

01 Election district, Berkeley	13,285
02 Election district, Jamestown	13,536
03 Election district, Powhatan	13,302
04 Election district, Stonehouse	13,147
05 Election district, Roberts	13,739

- (b) Staggered term election cycle by district Quadrennial election cycle:
 - 01 Election district, Berkeley, shall hold an election in 2011 and every four years thereafter;
- 02 Election district, Jamestown, shall hold an election in 2013 for a two-year term and a subsequent election shall be held in 2015, followed by an election every four years thereafter;

03 Election district, Powhatan, shall hold an election in 2013 for a two-year term and a subsequent election shall be held in 2015, followed by an election every four years thereafter;

04 Election district, Stonehouse, shall hold an election in 2011 2015 and every four years thereafter;

05 Election district, Roberts, shall hold an election in 2011 2015 and every four years thereafter.
