Mr. Icenhour asked if the \$170,000 contribution from the Walnut Grove community would decrease the \$413,000 amount.

Mr. Foster stated it would defray cost of the \$413,000 amount and the James City Service Authority would be responsible for the remainder.

BID AWARD - KRISTIANSAND SEWER REHABILITATION - \$413,175.39

- WHEREAS, the plans and specifications for the installation of a gravity sewer in the Kristiansand neighborhood along Nina Lane and Astrid Court have been advertised and publicly opened with Jack L. Massie Contractor, Inc. submitting the low bid of \$413,175.39, out of 14 firms that submitted bids; and
- WHEREAS, Jack L. Massie, Contractor Inc., has been determined capable of performing the work associated with the project and funds are available in the James City Service Authority budget.
- NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the James City Service Authority, James City County, Virginia, hereby awards the contract to perform the Kristiansand Sewer Rehabilitation Project to Jack L. Massie Contractor, Inc. in the amount of \$413,175.39.
