## DROUGHT CONTINGENCY PLAN

SUBJECT:	Utility Participation Agreement - Wellington Subdivision

Developers are required to provide on- and off-site water and sewer infrastructure of adequate size to serve their development. In its review and oversight role of plans for new development, the James City Service Authority (JCSA) attempts to coordinate future infrastructure needs. In certain cases this includes asking the developer to increase the size of a water/sewer line or sewerage pump station to accommodate future needs beyond those of the specific development. This approach precludes having to make major utility improvements to serve adjoining properties when developed. In many cases this will prevent the disruption of established road/streets and the proliferation of sewerage pumping stations serving individual developments. The approach can also offset the need for the JCSA to install water distribution lines to improve system hydraulics and pressures.

The JCSA's Regulations Governing Utility Service authorizes the JCSA to ask a developer to increase the size of water and sewer infrastructures over and above the size necessary to serve the needs of a specific development. The regulations further provide that the JCSA will reimburse the developer the additional costs associated with increasing the size of the utility infrastructure over and above what is needed for the specific development. To establish the terms for this arrangement, the JCSA must enter into a Utility Participation Agreement providing the terms for reimbursing the developer.

Because of its proximity to existing and future water/sewer lines and other undeveloped property, the Wellington Development provided an opportunity to increase the size of the water/sewer lines and the pump station. Negotiations were conducted with the developer and the incremental costs to increase the size of the water and sewer utilities were agreed upon as defined below:

Sewerage Pumping Station(450-1050gpm)	\$39,427
Water Line (10"to 12")	<u>16,268</u>
Total	<u>\$55,695</u>

It is recommended that the Board approve the attached resolution authorizing the Chairman to sign the attached Utility Participation Agreement which provides the terms for reimbursing the developer American Eastern Inc., for the additional \$55,695 in expenses incurred to increase the capacity of water and sewer infrastructure as requested by the JCSA to serve future system needs.

# UTILITY PARTICIPATION AGREEMENT -WELLINGTON SUBDIVISION

- WHEREAS, the James City Service Authority (JCSA) staff identified the opportunity to increase the capacity of the utilities to serve the Wellington Subdivision to provide for their integration into the JCSA infrastructure and improve the overall system; and
- WHEREAS, the Regulations Governing Utility Service allows the JCSA to enter into a Utility Participation Agreement with a developer to provide the terms of reimbursing the incremental costs to increase the size of the utilities' infrastructure over that need to serve the development alone; and
- WHEREAS, staff and American Eastern, Inc., have agreed on the amount of reimbursement necessary to compensate American Eastern for the expenses incurred to increase the size of their water and sewer facilities over that needed by their development.
- NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the James City Service Authority, James City County, Virginia, authorizes its Chairman to sign a Utility Participation Agreement with American Eastern, Inc., providing the terms of reimbursement for costs incurred to increase the size of a water and sewer infrastructure to serve the Wellington Development as requested by the JCSA staff.

SUBJECT: Utility Participation Agreement - U.S. Home Corporation

Section 29 D1(a) of the Regulations Governing Utility Service allow the James City Service Authority to reimburse a developer the incremental cost to upgrade water and sewer utilities beyond those needed by the development. In doing so, the additional capacity can be used to enhance and plan for meeting future JCSA needs.

The JCSA's FY 2003 budget included \$400,000 to rehabilitate two sewerage pumping stations adjacent to Route 60 in Lightfoot. U.S. Home is in the process of developing the Heritage at Williamsburg project, which is located immediately between the two sewerage pumping stations. By partnering with U.S. Home in the expansion of a sewerage pumping station and enlargement of some of its required gravity sewer lines and force main, the two pumping stations can be eliminated. This will permanently eliminate the requirement to maintain the two existing pumping stations planned for upgrade, and an estimated present value of \$800,000 to \$1,000,000 in life cycle costs to operate and maintain the two pumping stations over the next fifty years. One of the JCSA's objectives is to reduce the number of sewerage pumping stations wherever possible and economically feasible. This reduces long-term maintenance costs and the probability of sewerage spills.

An evaluation of the incremental costs to enlarge the U.S. Home pumping station and sewer lines is an estimated \$800,000. Taking into account the present worth value of operating and maintaining a larger (regional) pump station, and exercising this option to eliminate the two existing JCSA pump stations by making an \$800,000 investment now, will save \$200,000 to \$400,000 in present worth costs.

As referenced earlier, the FY 2003 budget includes an allocation of \$400,000 to cover the cost of upgrading the two pumping stations adjacent to the U.S. Home project. An additional \$400,000 is necessary to cover the entire costs of the replacement option. U.S. Home has agreed to allow the JCSA to make two additional \$200,000 payments in FY 2004 and FY 2005 to cover the costs of the agreement. Since the final contribution will be determined based on the actual costs of construction, provisions are made to make a third payment if necessary; however, a cap of \$900,000 has been agreed to by both parties.

Staff recommends that the Board approve the attached resolution authorizing the Chairman to sign a Utility Participation Agreement with U.S. Home providing the terms to upgrade portions of the sewer system improvements for the Heritage of Williamsburg project in order to eliminate two JCSA sewerage pumping stations located adjacent to the development.

# **UTILITY PARTICIPATION AGREEMENT - U. S. HOME CORPORATION**

SUBJECT: Award of Bid - Ewell Hall Water System Improvements

The plans and specification for replacement of the Ewell Hall water system have been publicly advertised and competitively bid. Five firms submitted bids ranging from \$188,191.50 - \$222,013.60. The results of the bids are as follows:

George Nice and Sons	222,013.60

The low bid submitted by Tidewater Utility Construction was very close to the design engineers estimate of \$182,000. It is also within budget and funds are available in the Capital Improvement Plan budget. While the James City Service Authority has no experience with Tidewater Utility Construction, a review of references indicates the firm is capable of performing the work associated with the project.

Staff recommends that the Board approve the attached resolution awarding the Ewell Hall water system improvements to Tidewater Utility Construction for a contract amount of \$188,191.50.

The low bid submitted by Walter C. Via, Inc., was within the design engineer's estimate of \$500,000. It is also within budget and funds are available in the Capital Improvement Plan budget. The James City Service Authority has had experience with the firm and references indicate the firm is capable of performing the work associated with the project.

Staff recommends that the Board approve the attached resolution awarding the project to Walter C. Via, Inc., for a contract amount of \$495,930.
