## RESOLUTION

## <u>RETIREMENT OF DEBT - SANITARY DISTRICT NUMBER 2</u>

- WHEREAS, the Board of Supervisors of the James City County Sanitary District Number 2 has indicated its desire to retire all debt within the District by participating in the Discount Purchase Program offered by the Farmer's Home Administration; and
- WHEREAS, the Board of Directors of the James City Service Authority has determined that it is in the Authority's interest that the District's debt be retired; and
- WHEREAS, it is anticipated that Sanitary District Number 2 will not have sufficient funds to retire the District's debt; and
- NOW THEREFORE, BE IT RESOLVED that the James City Service Authority will participate in the purchase of the outstanding debt of Sanitary District Number 2 by providing the necessary balance not to exceed \$295,000 required to retire the debt after available funds in the District are applied.
- BE IT FURTHER RESOLVED that the Board of Directors hereby approves that expenditure from the existing unobligated fund balance.
