Foster, General Manager, James City Service Authority, stated that an agreement with Jamestown-Yorktown Foundation to extend a waterline to serve Jamestown Settlement had been entered into and ten bids were submitted with the lowest responsive bidder, C.L. Waltrip, II, Inc., for \$191,991.

## JAMESTOWN SETTLEMENT WATER MAIN (97-B-003)

WHEREAS, the Foundation has agreed to reimburse the JCSA the costs of extending an eight inch water main from 4-H Club Road to the Settlement and the JCSA has agreed to pay the costs of upgrading the line size to a 12-inch main (approximately \$20,000); and

WHEREAS, the project has been competitively bid with C. Lewis Waltrip II, Inc., submitting a low bid of \$191,991.00.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of James City Services Authority, James City County, Virginia, awards the bid for the project to C. Lewis Waltrip, II, Inc.

## 2. Bid Award - Tutter's Neck Force Main

Mr. Foster stated that the sewer force main along Tutter's Neck Road had experienced failures and eight firms submitted bids with the lowest responsive bidder being Current Construction for \$82,631.
