1. Newport News Waterworks - Water Extension Agreement - Ball Metal Corporation

RESOLUTION

WATER LINE EXTENSION - BALL METAL

WHEREAS, Ball Metal Corporation is expanding its manufacturing facility located in the Grove area of the County; and

WHEREAS, Newport News Waterworks provides water to the Ball Metal facility; therefore, a Water Extension Agreement is necessary; and

WHEREAS, the Agreement provides the terms for extending the water system and requires a payment of \$16,562 to cover the cost of inspections, water tests, etc., which will be paid by Ball Metal.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of James City Service Authority, James City County, Virginia, hereby authorizes its Chairman to sign the Agreement with Newport News Waterworks providing the terms of the extension of the water service to Ball Metal Corporation.
