## **B. BOARD CONSIDERATIONS**

# 1. <u>Bid Award - Well Improvements W-22 (Ferncliffe Drive)</u>

Mr. Larry M. Foster, General Manager, stated that an upgrade of the well facility was necessary to realize the full production capacity from 200 to 450 gallons per minutes of the new well.

He stated that the low bid, submitted by Ferguson/Mills, Inc., was over the budgeted amount by \$70,000. He requested the project budget be amended by appropriation of \$70,000 from Water Supply Escrow.

Staff recommended approval of the resolution.

Mr. Edwards made a motion to approve the resolution.

The motion passed by unanimous voice vote.

#### **BID AWARD - W-22 IMPROVEMENTS**

WHEREAS,	the James City Service Authority desires to improve a well facility located at 115 Ferncliffe
	Drive to maximize the production capability of the well facility; and

- WHEREAS, the project has been advertised, designed, and competitively bid, with Ferguson/Mills, Inc., submitting a low bid of \$373,923.59; and
- WHEREAS, the low bid is higher than the Capital Improvement Program Budget allocation and additional funds are available in the Water Escrow Account.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the James City Service Authority, James City County, Virginia, awards the well facility improvement project (W-22) to Ferguson/Mills, Inc., and amends the FY 98 Capital Improvement Budget as follows:

2. <u>Bid Award - Rehabilitation of Lift Stations 1-1 and 4-8</u> 3. Bid Award - Rehabilitation of Lift Stations 3-1 and 3-3

Mr. Foster stated that the configurations of the wastewater pump station along Jamestown Road created excessive pressures resulting in three separate failures of the force main. He stated that modifications to the four pump stations would correct the problem.

He stated that the two projects were bid separately, with low bids submitted by Mallory Electric within budget appropriations for both projects.

Staff recommended approval of the resolution.

WHEREAS, Mallory Electric has been determined capable of performing the work associated with the two projects.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of James City Service Authority, James City County, Virginia, hereby awards the contract to rehabilitate Lift Stations 1-1 and 4-8 (98-B-0008) and Lift Stations 3-1 and 3-3 (98-B-0009) to Mallory Electric.

Mr. Magoon asked staff to send notice to the newspaper about bids being awarded for rehabilitation of lift stations along Jamestown Road.

# 4. Bid Award, Toano Waterline Improvement

Mr. Foster stated that bids for waterline improvements to improve the hydraulics of the water system in Toano area had been submitted with Godsey & Sons, Inc. as the lowest, responsive bidder.

Staff recommended approval of the resolution.

Mr. Magoon made a motion to approve the resolution.

The motion passed by unanimous voice vote.

## RESOLUTION

#### TOANO WATERLINE IMPROVEMENTS

WHEREAS, Godsey & Sons, Inc., submitted the low bid of \$342,342 to perform waterline improvements in the Toano area.

WHEREAS, the bid is below the engineers estimate and the budget appropriation.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of James City Service Authority, James City County, Virginia, hereby awards the contract for the Toano Waterline Improvements to Godsey & Sons, Inc., for \$342,342.
