B. MINUTES - January 9, 1989

Mr. Mahone asked if there were corrections or additions to the minutes.

C. PRESENTATION

1. <u>Certificate of Appreciation - Victoria Gussman</u>

Mr. Mahone read the resolution and presented the certificate of appreciation to Ms. Victoria Gussman.

WHEREAS, VICTORIA GUSSMAN has served James City County since 1979, during a period of unprecedented growth for the County; and

- WHEREAS, Tory has shown astute judgment, technical knowledge, and incisive problem solving skills in complex planning and development issues; and
- WHEREAS, her attributes have been recognized as she assumed a position in the Planning Department in January 1980, was promoted to Planning Director in September 1984, and appointed the County's first Manager, Development Management in August 1987; and
- WHEREAS, Tory, displaying a quiet strength, has contributed to the quality growth of this community through her leadership in projects such as the 1981 Update of the Comprehensive Plan, the 1985 Zoning Ordinance Revision, the Richmond Road Study, and the Ware Creek Reservoir project, culminating in the Corps of Engineers statement of intent to issue a permit and certification from the State Water Control Board.

2. <u>Hampton Roads Sanitation District - James R. Borberg, General Manager</u>

Mr. James R. Borberg, General Manager of Hampton Roads Sanitation District reported on the recent sewer force main rupture and resulting spill, giving chronological order of events, and stating the breakdown occurred because of improper construction at time of installation.

In response to questions concerning timely repair and equipment availability, Mr. Borberg replied that the repair time would have been the same even if the event had happened during a week day, although repair work could have been started earlier. He also stated that all equipment needed was available, except for specific parts that had to be made.

D. HIGHWAY MATTERS

Mr. Frank Hall, Resident Engineer for Virginia Department of Transportation, stated that bids will be taken on the Longhill Connector Road on February 21, with construction beginning approximately 45 days thereafter.

Mr. Norment asked about the status of a traffic analysis on speed limit in the Grove community.

Mr. Hall replied that the study will be made in two to three weeks.

Mr. Mahone asked if the Highway Department might consider raising the ticket charge for the Jamestown-Scotland ferry.

Mr. Hall responded that he was unaware of a study at this time. He further stated that the Commissioner of Virginia Department of Transportation would be requesting approval of additional staff for ferry service from the current General Assembly.

E. PUBLIC HEARINGS

Mr. Marvin Sowers, Director of Planning, introduced a new employee, Donald E. Davis, Principal Planner, who came from the City of Jacksonville, North Carolina.

Mr. David Norman, County Administrator, requested an executive session on land acquisition, and noted a work session with the Planning Commission was scheduled for 2:00 p.m.

I. BOARD REQUESTS AND DIRECTIVES

- Mr. Mahone stated that his established office hours would be 3:00 \pm 5:00 p.m. on Thursdays in Building C at the Government Complex.
- Mr. Mahone indicated his intention of continuing the luncheon meetings with Mayor John Hodges, City of Williamsburg.
- Mr. Mahone encouraged Board members to give reports from the meetings of Boards and Commissions on which they serve.
- Mr. Mahone expressed regret that, at the last meeting, he neglected to recognize former Chairman Edwards' service during a difficult two-year period. On behalf of the Board, Mr. Mahone thanked Mr. Edwards for his service to the Board and local government.
- Mr. DePue acknowledged Mr. Trist McConnell, Councilman from the City of Williamsburg, in the audience, and thanked him for his efforts concerning area growth matters on the Regional Issues Committee.
- Mr. DePue also thanked the James City County Fire Department for its quick response to a chimney fire at his residence on Sunday. He urged citizens to have their chimneys cleaned regularly to avoid such emergencies.
- Mr. Mahone recessed the Board for a work session with the Planning Commission on Agricultural, Forestal, and Rural Residential Areas at 2:05 p.m.
- Planning Commissioners in attendance were Carolyn Lowe, Fred Belden, Alexander Kuras, and A.G. Bradshaw.
- Mr. Sowers presented the goals of the project and stated the main issue was that of scattered growth, with the problems created in areas where public services are unavailable. He introduced Mr. John I. Cofer of John I. Cofer & Associates, Inc.
- Mr. Cofer explained the process of preparing the report and suggested that the County approach be one of requiring a substantial minimum lot size, design flexibility for subdivisions, and special use permits with Board of Supervisors review.

Discussion followed regarding the effect on moderate income families, difference of A-1 and A-2 districts, minimum lot size requirement, and effect on land value.

- Mr. Mahone reconvened the Board into open session at 4:20 p.m.
- Mr. Mahone declared the Board in recess for a James City Service Authority Board of Directors meeting at 4:20 p.m.
- Mr. Mahone reconvened the Board into open session, and immediately convened the Board into executive session to discuss land acquisition pursuant to Section 2.1-344 (a)(2) of the Code of Virginia, 1950, as amended, at 4:55 p.m.

Mr. Mahone reconvened the Board into open session.



AN ORDINANCE TO VACATE A PORTION OF THAT CERTAIN SUBDIVISION PLAT ENTITLED, "MIDLANDS, SECTION ONE, BERKELEY DISTRICT, JAMES CITY COUNTY, VIRGINIA," DATED JULY, 1985, AND MORE PARTICULARLY DESCRIBED AS THAT UNNAMED .072 ACRE TRIANGLE OF RIGHT OF WAY ADJACENT TO THE INTERSECTION OF MIDLANDS ROAD AND STRAWBERRY PLAINS ROAD.

- WHEREAS, application has been made by Mr. Joseph S. Terrell and Essie G. Terrell, owners of all property adjacent to right-of-way proposed for vacation, to vacate certain lines, words, numbers and symbols on a plat more particularly described below; and
- WHEREAS, notice that the Board of Supervisors of James City County would consider such application has been given pursuant to Section 15.1-482 and, 15.1-431 of the Code of Virginia, 1950, as amended; and
- WHEREAS, the Board of Supervisors did consider such application on the 9th day of January, 1989, pursuant to such notice and was of the opinion that such vacation would not result in any inconvenience and is in the interest of the public welfare.
- NOW, THEREFORE, BE IT ORDAINED by the Board of supervisors of James City County, Virginia:
 - 1. That a portion of a certain subdivision plat entitled, "Midlands, Section One, Berkeley District, James City County, Virginia," dated July, 1985, prepared by AES, a professional corporation, Williamsburg, Virginia, and recorded in Plat Book 42, Page 51, be vacated so as to permit the recordation of a new plat that will serve to remove certain lines, words, numbers and symbols as more specifically set forth in said plat and thereby vacating that .072 acre triangle of right of way adjacent to the intersection of Midlands Road and Strawberry Plains Road.
 - That a new plat entitled, "Plat of Vacation, Boundary Line Adjustment and Lot Line Extinguishment, Property of Joseph S. and Essie G. Terrell, James City County, Virginia," dated May 19, 1988, prepared by AES, a professional corporation and approved by James City County, be put to record in the Clerk's Office of the Courthouse for the City of Williamsburg and County of James City, Virginia.

This ordinance shall be in full force and effect from the date of its adoption.
