1. Agricultural and Forestal District Policies

Mr. Sanford Wanner, County Administrator, introduced Mr. O. Marvin Sowers, Director of Planning and Mr. Gary Pleskac, Senior Planner, who introduced Agricultural and Forestal District Advisory Committee members in the audience.

Mr. Pleskac gave a review of the process, activity since the 1994 review, policy changes since the 1994 renewal, length of terms, proposed change in conditions and proposed administrative changes.

Staff described use value assessments as the practice of assessing real property on the basis of its use, using an estimate of revenue produced by an acre of land in a particular use category, rather than an estimate of market value.

After group discussion, the Board indicated its preference to set four years as the length of term and to strongly encourage landowners to seek longer terms.
