2. MINUTES - SEPTEMBER 5 AND OCTOBER 10, 1984

On a motion by Mr. Axtell, seconded by Mr. Poulsen, the minutes were approved by a 5-0 vote.

BOND CLOSING - ROBERT J. AND JANICE A. KUBICKI

Mr. Frank Morton indicated that this project had been much discussed. He suggested a few minor changes to the documents and indicated that the bond registrar be amended to read "the Dominion Bank of Hampton Roads, N.A., or an alternative acceptable to both the Applicant and to the Authority".
