## 2. MINUTES

Mr. Poulsen requested that page 2, paragraph 2, be changed to reflect his intent to resign from the Authority only if there is not a change of attitude by the Board of Supervisors.

Upon a motion by Mr. Poulsen, seconded by Mr. Hairfield, the minutes of the May 20, 1987 meeting were accepted with the above change.

#### 3. BALL CORPORATION

Mr. Arthur Anderson was present on behalf of Ball Corporation.

## 5. MATTERS OF SPECIAL PRIVILEGE

Mr. Axtell stated that in a discussion with Mr. Norman he was informed that John Brown's position as Economic Development Planner had not been filled. Further, that because of complexities involved with several issues Mr. Norman informed him that his report to the Board of Supervisors would probably be in late July.

Mr. McDonald reported that approximately 30 responses had been received following the ad in PACE Magazine. Two of the responses were directed at residential development while several addressed businesses, one a Dallas firm regarding warehousing and another regarding a brick manufacturing plant.
