1. Authorizing Resolution for Williamsburg Landing, Inc., Series 1996 Bonds

2. Farmer's Market

Mr. Wanner informed the Authority that Mr. Andrew Bradshaw, counsel to the James City Growers' Coop, requested a special meeting to discuss options available to the Market in order to maintain operations.

Mr. Nystrom recommended, that while the Authority would be willingly to maintain the same rental rate, he would not support further subsidies. The Authority has supported the Farmers' Market throughout its tenure, however, the Farmer's Market continues to be a declining business venture.

Executive Session

Mr. Taylor recommended that the Authority go into Executive Session pursuant to Section 2.1-344 (A)(5) of the Code of Virginia to begin a discussion concerning the disposition of real property

On the recommendation of Mr. Taylor, Mr. Nystrom considered a motion from Mr. Bartlett to convene into Executive Session at 8:25 a.m.

Chairman Nystrom reconvened the Authority into open session at 8:55 a.m. and considered a motion from Mr. Bartlett to approve the Resolution Certification of Executive Session.

Mr. Nichols informed the Authority that he is scheduled to attend the Virginia Institute of Economic Development Seminar at Virginia Tech. He will be unable to attend the complete program and asks if any of the Directors would replace him at the conference.

Mr. Cross recommended that the Authority become more involved in the final phase of the Comprehensive Plan. He noted several inaccuracies that the Authority should represent in proper context to the Planning Commission before final approval. Mr. Bartlett requested copies of the Planning Staff's analysis and recommendations.

4. ADJOURNMENT

There being no further business, Mr. Nystrom entertained a motion by Mr. Campana to adjourn. The motion was seconded by Mr. Demer and passed unanimously by voice vote. The meeting was adjourned at 9:00 a.m.
