2. <u>APPROVAL OF MINUTES</u>

On a motion by Mr. Nystrom and a second by Mr. Campana the minutes of the December 10, 1998 and December 28, 1998 meetings were approved by unanimous voice vote.

3. TREASURER'S REPORT

The Treasurer's Report from Ms. Davis for the Authority was presented by Mr. Taylor, along with the Capital Improvement Expenditure Report and the IDA operating budget report. On a motion by Mr. Nystrom, and a second by Mr. Greenwood, the Treasurer's Report and related financial reports were accepted as presented by unanimous voice vote.

4. <u>PERSONNEL MATTERS</u>

a. Board of Supervisors and Planning Commission Liaison Appointments

Mr. Bartlett reported that he asked Mr. Demer to continue on as the Planning Commission Liaison for the IDA and Mr. Demer agreed. He further reported that he felt it important to have the IDA Chairman as the liaison to the Board of Supervisors. Everyone was in agreement with this.

- 7. <u>REPORTS</u>
 - a. BOS Liaison to IDA

Mr. Nervitt reported that the BOS is working on having two meetings a year with the various appointed boards, authorities and commissions. He further reported that the BOS reassignments have been done and he has asked to remain the IDA liaison. Mr. Nervitt also mentioned that he would like see the IDA promote the new Research and Technology Zone.

b. Planning Commission Liaison

Mr. Demer stated that there were no issues to report at this time.

c. Peninsula Alliance for Economic Development

Mr. Nystrom reported that the Alliance is discussing an action plan for the year, to include business recruitment and workforce training. He further reported that the new President and CEO, Richard Weigel is an excellent addition to the Alliance.

d. Business & Industrial Zoning Ordinance Review Committee

Mr. Campana reported that the Committee sent a letter to Board of Supervisors Chairman, Jack Edwards regarding the new research and technology district.

e. Strawberry Plains Road Property Sales Status

Mr. Campana reported that the committee met with the prospective purchasers and everyone was pleased with the results of the prospective purchaser's plans for the property. He further stated that the deed has been signed and the closing is scheduled to take place on January 15, 1999.

f. Strategic Plan Update

Mr. Taylor reported that the teams have met and the draft will be finished soon. The IDA will then need to hold a meeting to finish up the plan, after which they will have a work session with the Board of Supervisors to get their input and approval.

g. Chairman's December 17 Procedural Suggestions

Chairman Bartlett stated that staff has put together a notebook for the directors to put there various correspondence, etc. in regarding the IDA and that the Directors should maintain the notebooks themselves. He also stated that the IDA may want to reconsider where they hold their meetings and possibly hold the regular IDA meetings in a different location. Chairman Bartlett also suggested that the directors who do not have e-mail access might consider getting it as this may be a good communication tool for the IDA.

h. Questions Concerning Written Staff Reports

Mr. Taylor stated that there was no written report this time do to the shortness of time between regular meetings.

Mr. Taylor reported that Mr. Wayne Sterling will be leaving the Virginia Economic Development Partnership to return to South Carolina.

He further stated that the next Business Leaders' Breakfast will be held at Kingsmill on Feb. 24, 1999. Mr. Taylor is considering asking Mr. Richard Weigel speak at the function regarding the Peninsula Alliance for Economic Development.

Mr. Taylor reported that there is an upcoming Virginia Economic Developers Association seminar to be held in March and invited any directors to sign up if they are interested.

Mr. McDonald, Manager of Financial Management Services for James City County put together a draft list of the outstanding industrial revenue bonds per Mr. Bartlett's request and this list has been distributed to the IDA directors.

The James City County Attorney's office has put together an extensive group of Attorney General's opinions regarding the IDA. Mr. Herrick, Assistant County Attorney found 69 opinions and put together 20 for the Chairman Bartlett's review.

8. <u>OTHER BUSINESS</u>

a. Crossroads Project

Mr. Demer asked the IDA if they want to take a position on this issue. Mr. Nystrom stated that there are definitely economic development issues in the study. Mr. Greenwood stated that he will put all of the IDA directors on the mailing list regarding information for the study, informational purposes.

b. Regional Industrial Park Concept

Mr. Demer suggested that the IDA purchase land to help facilitate potential prospects getting into the industrial parks. He further stated that the IDA may want to consider this as an option, as well as explore the regional industrial park concept.

c. Greater Richmond Mayors and Chairs

Mr. Demer suggested that the IDA of JCC connect with the IDAs of Richmond to get information from them as to some of their practices and policies. He also suggested that it would be to the IDA's advantage to meet with them. It was then suggested that there be a formal liaison representative from JCC's IDA appointed. Mr. Nystrom suggested that other IDA chairs could come and address the County's IDA. Mr. Nichols suggested having a consultant speak to the IDA to inform the IDA of their process in finding a site for relocation.

9. EXECUTIVE SESSION

Mr. Taylor recommended that the IDA go into Executive Session pursuant to Section 2.1-344 (A) (3) of the Code of Virginia to consider the lease of a parcel of publically held property. On a motion made by Mr. Campana and seconded by Mr. Nichols, and approved by unanimous voice vote, the IDA went into Executive Session at 4:55 p.m.

On a motion made by Mr. Nystrom and seconded by Mr. Nichols, and approved by unanimous voice vote, the IDA came out of Executive Session at 5:34 p.m.
