#### 3. APPROVAL OF MINUTES

On a motion by Mr. Berkenkamp and a second by Mr. Rinaldi, the minutes from the May 11, June 12 and June 30, 2000 meetings were approved by unanimous voice vote.

#### 4. <u>FINANCIAL REPORTS</u>

#### a. Treasurer's and Financial Reports

Mr. Taylor and Ms. Christian briefly presented the Treasurer's Report and answered questions.

#### b. Operating and CIP Budget Reports

Mr. Taylor and Ms. Christian presented the Capital Improvement Expenditure Report and the IDA Operating Budget Report. On a motion by Mr. Berkenkamp and a second by Mr. Campana, the Treasurer's Report, the IDA Operating Budget, and the CIP Reports were accepted by unanimous voice vote. Mr. Berkenkamp requested a more complete accounting of the cost, revenue and residual values associated with the County's first shell building project. Mr. Taylor said he would request this of the IDA's Fiscal Agent.

#### 5. PERSONNEL MATTERS

#### a. Summer Intern for OED

Mr. Bartlett introduced and welcomed Virginia Hartmann as the IDA's newest Director.

#### b. Election of Vice Chairman

Mr. Bartlett asked Mr. John Berkenkamp to fill the remaining term of Vice Chairman. Mr. Berkenkamp stated that he would be very happy to serve in that capacity. On a motion by Mr. Campana and a second by Mr. Rinaldi, the nomination was approved by unanimous voice vote.

#### c. Resolution for Outgoing IDA Director Demer

On a motion by Mr. Berkenkamp and a second by Mr. Rinaldi a resolution of appreciation for Mr. Demer's service on the IDA was passed by unanimous voice vote.

#### 6. <u>ACTION ITEMS</u>

#### a. Authorization to Approve James River Commerce Center Easement Agreement

Mr. Rogers briefly explained the easement agreement between Ball Metal Beverage Container Corp. and the IDA at James River Commerce Center. He then answered questions from the directors. On a motion by Mr. Berkenkamp and a second by Mr. Rinaldi, the resolution was approved by unanimous voice vote.

# 7. <u>PRESENTATION</u>

#### Economic and Fiscal Impact Analyses of Technology-Driven Companies

Mr. Taylor introduced Kendra Langlois who gave a presentation of her economic and fiscal impact analyses drafts she is preparing for the County Administrator. She then answered questions from the directors.

#### 8. <u>REPORTS</u>

#### a. BOS Liaison to IDA

Mr. Kennedy welcomed Ms. Hartmann as the newest IDA Director. He solicited the IDA's input on "big box retail" and affordable housing.

#### b. Planning Commission Liaison

Mr. Bartlett asked Mr. Rinaldi if he would take over as Planning Commission Liaison. He explained that it is mostly a passive role. He would need to observe and report to the IDA any issues relating to the IDA. Mr. Rinaldi stated that he would be happy to do so.

#### c. Peninsula Alliance for Economic Development

Mr. Bartlett stated that he had been appointed to the marketing committee of the Alliance.

#### d. Crossroads Project Liaison

Mr. Bartlett noted the recent agreement between the Casey family and William & Mary's Endowment Association to develop a 300-acre tract at the Crossroads area.

# e. Research & Technology District Task Force

Mr. Campana stated that the task force will have a joint meeting with the Board of Supervisors on September 25, 2000. Two members of the Research & Technology District Task Force will meet with each of the Board of Supervisors individually prior to the September meeting.

#### f. Economic Development Initiatives

Mr. Rinaldi stated that some of the items discussed at the joint IDA/BOS meeting will be part of the economic development initiatives.

#### g. June 12 Work Session Outcomes with Board of Supervisors

Mr. Bartlett produced a two page report as a result of the joint IDA/BOS meeting. He asked the other directors to do the same if they have thoughts about the joint meeting they would like to convey. Mr. Berkenkamp stated that he would be interested in taking item numbers four and eight on Mr. Bartlett's report and proceeding with them.

#### 9. REPORTS OF THE ECONOMIC DEVELOPMENT STAFF

# a. Shell Building #2 Due Diligence Recommendations

Mr. Taylor stated that in the past the IDA retained a consultant on siting and developing the first shell building. He asked the chairman to assign one IDA director to work directly with the Office of Economic Development in preparing a similar consultant RFP for shell building #2. Mr. Campana volunteered to help with this project.

# b. James City County Fair

Ms. Barner reported that the County Fair will be held on Saturday, August 12 and she asked the IDA Directors for volunteers to help man the booth.

#### 10. OTHER BUSINESS

Mr. Campana stated that as a result of the joint meeting with the Board of Supervisors, the IDA may need to have a special meeting to go through the charges given by the Board.

Mr. Rinaldi stated that IDA has a lot that has been asked of it and this may require monthly meetings.

Mr. Bartlett asked that any reports by IDA Directors be done in writing 10 days prior to the meeting.

#### 11. <u>ADJOURNMENT</u>

There being no further business Chairman Bartlett entertained a motion from Mr. Rinaldi to adjourn. The motion was seconded by Mr. Campana and approved by unanimous voice vote. The meeting was adjourned at 5:30 p.m.
