#### 3. DISCUSSION

a. James River Commerce Center Utility Easement

Mr. Yavorsky gave an overview of negotiations with Jamestown Management Company, LLC (JMC) to install public water and sewer lines and to convey necessary easements across the EDA's property in James River Commerce Center.

Mr. Bennett handed out a page of Trusswood Utility Extension Considerations, and discussed them with the Directors.

There being no quorum, the Directors present gave Mr. Bennett the consensus that on the issue of the easement location, the proposed location is acceptable.

Mr. Rogers and Mr. Yavorsky were instructed to meet again with JMC and negotiate other issues still on the table and bring a resolution to the next EDA meeting for vote

#### b. Economic Development Use of Rural Lands Subcommittee

Mr. Rinaldi asked if any Directors present had given thought to the charter for the Economic Development Use of Rural Lands Subcommittee. Mr. Tingle stated that the EDA Nominating Committee had submitted recommendations to the BOS for consideration, and that those persons whose names were submitted would be excellent candidates for the Committee.

Ms. Musser reminded the Directors that Ms. Hartmann had volunteered to be an EDA representative on the Subcommittee. Mr. Tingle suggested the make up and charter for the committee not be discussed further until the next meeting when Ms. Hartmann could be in attendance, and the BOS may have made an appointment for the expiring Director position.

#### c. Prepare and Profit, What YOU Wanted

Ms. Musser shared information on the upcoming Seminar scheduled September 25, referring to the request letter from Ms. Margaret Tucker for financial assistance from the EDA to cover expenses. Ms. Musser stated printing costs were the largest need at present, and these costs would be approximately \$800. Mr. Taylor reminded the EDA that they have a discretionary account from which funds can be spent without it having to go before the EDA for a vote. Mr. Rinaldi authorized Mr. Taylor to cover expenses for printing flyers and registration forms for the event, according to EDA policy for the discretionary account.

#### 4. <u>REPORTS</u>

Mr. Taylor reviewed the EDA Policy for Travel Related Business Expenditures, stating that the EDA Secretary signs off on any such expenses for EDA agents or other Office of Economic Development Staff, and the EDA Chair or his/her other Director designee should now sign off on any such expenses incurred by the EDA Secretary.
