4. APPROVAL OF MINUTES

Mr. Rinaldi entertained a motion by Mr. Gebhardt to approve the minutes of the May 17, 2007 EDA Meeting and June 19, 2007 EDA Work Session. The motion was seconded by Mr. Warner and passed unanimously.

5. FINANCIAL REPORTS

Mr. Keeler presented the Treasurer's and Financial Reports for May-June 2007, stating there was little activity. There being no questions or discussion, Mr. Rinaldi entertained a motion by Mr. Craft, seconded by Ms. Hartmann, to accept the reports as presented, which passed unanimously.

6. PRESENTATION

Mr. Early gave an update on the clients, prospects and progress of the JCCTI and answered questions posed by the Directors. Mr. Craft expressed his concern at the lack of in-house clients, after which there was a lengthy discussion of possible solutions and plans of action.

7. ACTION ITEMS

a. James River Commerce Center Utility Easement Extention

Mr. Bennett and Mr. Oliver presented a timeline and issues that need to be resolved regarding the utility easement. Mr. Yavorsky and Mr. Rogers clarified issues they had discussed with Jamestown Contracting in the weeks leading up to today's EDA meeting.

After a question and answer period, Ms. Hartmann made a motion that the EDA empower its chairman to execute all documents necessary to provide Jamestown Contracting the requested utility easement through James River Commerce center in accordance with the terms and conditions set forth in Mr. Yavorsky's and Mr. Rogers' July 19, 2007 memorandum to the EDA Directors, as corrected [Paragraph Three, Sentence Four, "\$7000" changed to "\$7.00"]. Mr. Craft seconded the motion which passed unanimously

b. Hampton Roads Association for Commercial Real Estate (HRACRE) Excellence in Design Awards

Mr. Taylor explained that HRACRE had again asked that the EDA sponsor HRACRE's Excellence in Design Awards. This has been an annual sponsorship the Director's have approved for a number of years, though this year the sponsorship has increased from \$300 to \$350. Mr. Gebhardt made a motion that the EDA participate again as a sponsor, which was seconded by Mr. Warner and passed unanimously

8. <u>DISCUSSION ITEMS</u>

a Economic Development Use in Rural Lands Sub-Committee.

Mr. Rinaldi began the discussion by asking explaining that Ms. DuBois and Ms. Hartmann would serve on the sub-committee. He then asked Mr. Bradshaw to give a brief background of the BOS' intentions for the EDA to investigate this matter.

Mr. Bradshaw explained that the County recognized they need to approach rural lands differently than they have in the past. In preparation for the comprehensive plan update, the BOS wants to explore what uses might be suitable for rural lands, and to better understand and promote uses that are consistent with what the County wants rural lands to become and/or remain. The BOS, like the EDA, does not have a lot of experience or understanding, but knows there is a lot surrounding the issue of economic development uses in rural lands which could be explored and/or implemented, which is the particular program the BOS has asked the EDA to take on.

There was discussion of the issues following Mr. Bradshaw's explanation, and it was determined that further discussion would be needed at the next EDA meeting.

b. Former Candle Factory Property

Concern was expressed, and discussion followed on the process being employed regarding site plan review and permissions for the former Candle Factory property, as well as other projects being presented to the Planning Commission.

9. REPORT

a. Business Climate Task Force
Mr. Bradshaw, Mr. Yavorsky and Mr. Taylor brought the EDA up to date on the progress of the BCTF. The final report is expected after the first of the year.

10. REPORTS OF ECONOMIC DEVELOPMENT STAFF

a. In the interest of time, Mr. Taylor shared with the EDA that there were a number of projects presently on the table for OED staff, and briefly reviewed dates for upcoming events.

12. ADJOURNMENT

There being no further business, Chairman Rinaldi entertained a motion by Ms. Hartmann to adjourn, which passed unanimously. The meeting was adjourned at 5:20 PM.
