BE IT ORDAINED by the Board of Supervisors of the County of James City, Virginia, that Chapter 14, Outdoor Gatherings, is hereby amended and reordained by amending Section 14-4, Application for permit.

Chapter 14. Outdoor Gatherings

Sec. 14-4. Application for permit.

Written application for a permit to hold an outdoor gathering shall be made to the county administrator or his designee. The application shall be submitted at least 90 days prior to the date upon which the gathering is to be held. Such application shall be on forms provided by the county and shall have attached thereon plans, documents, approvals and other material required by this chapter.

(b) The fee for each outdoor gathering permit shall be \$50.

This ordinance shall become effective on July 1, 1999.

Budget Ordinance Amendments - Fees

Attached for your consideration are two ordinance amendments to implement the Fiscal Year 2000 budget. The ordinance amendments are as follows:

A. Section 9-3. Fire Prevention Code. (Effective for July 1, 1999)

This Ordinance increases the fireworks fee from \$50.00 per event to \$100.00 per event or from \$100.00 to \$200.00 per calendar year (at same site with similar displays). The Ordinance also establishes a \$50.00 fee for each waste open burning permit and a \$25.00 fee for each bonfire permit.

B. Section 14-4. Outdoor Gatherings. (Effective July 1, 1999)

This Ordinance establishes a \$50.00 fee for each outdoor gathering permit.

Staff recommends that the Board hold the public hearing at this meeting but withhold adoption of these ordinance amendments until after the Fiscal Year 2000 Budget has been adopted.
