2. INTRODUCTIONS

Mr. Foster welcomed everyone and gave an invocation.

Mr. Sowers introduced members of the Planning Department staff and briefly described the Division's organization.

Mr. Horne introduced Mr. Lindstrom, a former member of the Albemarle County Board of Supervisors, a member of the faculty of the University of Virginia teaching Planning Law, a member of the Institute of Environmental Negotiations, and a practicing attorney.

3. <u>PROGRAM</u>

Mr. Lindstrom described his range of experience during 12 years on the Albemarle County Board of Supervisors, including serving as the Board's liaison to the Planning Commission. Mr. Lindstrom compared James City and Albemarle Counties, specifically regarding rapid growth.

Mr. Lindstrom felt that the heavy subsidy required in terms of public services and infrastructure for new development is adequate reason for public concern and involvement in development decisions and planning.

Mr. Lindstrom emphasized that the Planning Commission and staff should be apolitical. The Commission along with the staff recommendation should consider public opinion in developing their opinions, but should not act as politicians responsive to a constituency. The Planning Commission should act as a consultant to the elected body, offering advice and objective evaluations of facts. The Commission and staff roles should be that of gathering and considering all information and options and making objective recommendations based on a long-term view of the County's overall needs and best interests. Staff should be comprehensive and unwavering in their recommendations.

Mr. Lindstrom stressed that predictability is of the utmost importance to developers, so that time and resources are not wasted on proposals that do not succeed.

Mr. Lindstrom further stressed the need to avoid reactive planning, in general. He stated that giving the people what they want now does not necessarily give them what they need, and does not preclude them from demanding what they will still need in the future.
