


RESOLUTION

WHEREAS, James City County is represented on the Greater Peninsula Private Industry Council; and


WHEREAS, State guidelines require that each jurisdiction represented on the Council endorses the nominations to the Council.

SUMMARY OF THE
PRIVATE INDUSTRY COUNCIL
NOMINATION PROCESS

Under the provisions of the Job Training Partnership Act (JTPA), the responsibility for the selection of members to serve on the Private Industry Council (PIC) has been assigned to the local elected officials of the localities that comprise the various jurisdictions of the Service Delivery Area (SDA) (Newport News, Hampton, Williamsburg, Poquoson, York, James City, and Gloucester).

Each PIC is required to have representation from the private sector, community based organizations, education, labor, rehabilitation, economic development, public employment service and social services. In accordance with the regulations, private sector nominations must be made by general purpose business organizations (e.g. chambers of commerce). It is the responsibility of the Consortium of Governments (COG), the body representing the seven municipalities which comprise the SDA, to review nominations to ensure that all guidelines are being met. Nominations are then submitted to the respective governing bodies for approval. Once nominations are approved by the local elected officials, the appointments are then forwarded to the Governor's Employment and Training Department for certification.
