## RECORDATION TAX EXEMPT PER CODE OF VIRGINIA, 1950, AS AMENDED, SECTION 58.1-811 A (3)

THIS DEED OF EASEMENT, made this <u>28</u><sup>th</sup> day of <u>Morck</u>, 2000, by and between <u>JAMES CITY COUNTY</u>, hereinafter referred to as "GRANTOR;" and the JAMES CITY SERVICE AUTHORITY, created by the County of James City, Virginia, organized and existing under the laws of the Commonwealth of Virginia, hereinafter referred to as "GRANTEE."
