RESOLUTION

GRANTING AN EXCEPTION ON JCC RE TAX PARCEL NO. 1640600001

- WHEREAS, Mr. William G. Casto, (the "Applicant") has appeared before the Chesapeake Bay Board of James City County (the "Board") on September 8, 2010 to request an exception for use of the Resource Protection Area (the "RPA") on a parcel of property identified as JCC RE Tax Parcel No. 1640600001 and further identified as 142 Riverview Plantation Drive (the "Property") as set forth in the application CBE-11-023 for two retaining walls; and
- WHEREAS, the Board has listened to the arguments presented and has carefully considered all evidence entered into the record.
- NOW, THEREFORE, following a public hearing, the Chesapeake Bay Board of James City County by a majority vote of its members FINDS that:
 - 1. The exception request is the minimum necessary to afford relief.
 - 2. Granting the exception will not confer upon the Applicant any special privileges denied by Chapter 23, Chesapeake Bay Preservation, of the James City County Code, to other property owners similarly situated in the vicinity.
 - 3. The exception request will be in harmony with the purpose and intent of Chapter 23 of the James City County Code, and is not of substantial detriment to water quality.
 - 4. The exception request is not based on conditions or circumstances that are self-created or self-imposed, nor does the request arise from conditions or circumstances either permitted or non-conforming that are related to adjacent parcels.
 - 5. Reasonable and appropriate conditions are hereby imposed, as set forth below, which will prevent the exception request from causing a degradation of water quality.
 - 6. In granting this exception, the following conditions are hereby imposed to prevent this exception request from causing degradation of water quality:
 - a) The applicant must obtain all other necessary local permits as required for the project.
 - b) An RPA Mitigation Plan, meeting James City County requirements, shall be submitted and approved
 - c) All proposed mitigation plantings shall meet James City county standards of l" caliper for the canopy and understory trees and three gallon size shrubs.

- d) Full implementation of the RPA Mitigation Plan and any additional Board mitigation requirements shall be guaranteed through the provisions of the Ordinance contained in Sections 23-10(3) d. and 23-17(c) by providing a form of surety satisfactory to the County Attorney.
- e) This exception request approval shall become null and void if mitigation plantings have not been completed by <u>September 8, 2011</u>.
- f) Written requests for an extension to an exception shall be submitted to the Environmental Division no later than 2 weeks prior to the expiration date.
