1. Mr. Robert Richardson, 2786 Lake Powell Road, commented on the \$115,000 per year allocation to honor an agreement to purchase water from Newport News Waterworks (NNWW) for a project that does not exist. He commented the contract would cost \$1.6 million per year for 32 years.

SUBJECT: Bid Award – Stonehouse W-25 and W-26 Water Facility Improvements

The plans and specifications for the Stonehouse W-25 and W-26 Water Facility Improvements have been publicly advertised and competitively bid. The project consists of the installation of variable frequency drives and instrumentation in W-25 and W-26 and the replacement of the control panel in W-26. The project is necessary to replace the antiquated control system and motor starters with a more energy efficient system with greater flexibility of control for the water system. One (1) bid was received as follows:

Systems East Inc. \$211,919

Systems East Inc. bid has been determined to be responsive and responsible.

The bid is below the engineer's final cost estimate of \$317,000 and adequate funds are available for the project.

The plans and specifications for the Longhill Connector Road Water Main Extension have been advertised and competitive bids publicly opened with ten firms submitting bids. The project includes 4,300 feet of 16-inch water main from The Mews to Ironbound Road which will improve water system hydraulics to the Northwestern part of the County. The firms and bid amounts are as follows:

The low bid of \$534,057 submitted by Jamestown Contracting, LLC is below the design engineer's estimate of \$700,000 and within budget. Jamestown Contracting, LLC favorably performed similar work for the James City Service Authority in the past and has been determined capable of completing the scope of services required for this project.
