The James City Service Authority (JCSA) has been awarded two Dam Safety Grants by the Virginia Department of Conservation and Recreation (DCR) Dam Safety and Floodplain Management Division in the amounts of \$1,000 and \$4,000. The funding source is the Virginia Dam Safety, Floodplain Prevention and Protection Assistance Fund.

The JCSA owns the earthen dam located along Point O'Woods Road in the Mirror Lakes neighborhood. The \$1,000 grant reimburses the JCSA for nine percent of the cost of an Alternatives Analysis engineering study, which was required by DCR. The study evaluated three alternatives for renovations needed to meet the Commonwealth's Impounding Structure Regulations and included a cost summary for each alternative. The \$4,000 grant reimburses the JCSA for seven percent of the cost of Renovation Engineering Services to design the selected alternative of adding additional pipes as a secondary spillway. Timmons Engineering performed the Alternatives Analysis study and will design the secondary spillway.

The grants require a 50 percent match. The matching funds for these reimbursement grants were provided in the JCSA's Capital Improvements Program (CIP) budget.

Staff recommends adoption of the attached resolution.

SUBJECT: Transfer of .288-Acre Parcel - Located at 7855 Church Lane - to James City County

The James City Service Authority (JCSA) owns a .288-acre parcel of property identified as James City County Tax Map/Parcel No. 1230100048 located at 7855 Church Lane. A well facility that has not been used in over 15 years is located on the parcel. There are no plans to use the well facility for water production in the future; however, there are plans to convert the facility to a water quality monitoring station.

The JCSA parcel is located immediately adjacent to the Bruton Fire Station. A new fire station is currently being designed at the existing site and will be competitively bid in the very near future. The JCSA parcel, if assembled with existing parcels, will complement the new fire station. The existing well facility can be retained for JCSA use as a monitoring station after transferring to James City County for use with the planned fire station. It is recommended that the parcel be transferred to James City County at no cost to acknowledge the County's after-hours dispatch services.

It is recommended that the Board approve the attached resolution authorizing the General Manager to sign the appropriate documents transferring the parcel to James City County at no costs. The transfer will include an agreement that provides access and egress to the existing well facility to allow the JCSA to use the structure for a water quality monitoring station.





Authorization to Enter into a Lease Agreement with the Hampton Roads Sanitation District

("HRSD") for a Pressure Reducing Station

Attached is a resolution authorizing the General Manager to amend the deed restrictions and enter into a lease agreement with the Hampton Roads Sanitation District ("HRSD") for the property located at 6735 Route 199, further identified as Parcel No. 4920100006A on the James City County Real Estate Tax Map (the "Property"). A map of the Property is attached. Currently, a James City Service Authority (JCSA) water tank is located on the Property. The lease agreement is necessary to allow the HRSD to construct a proposed pressure reducing station on the site. Installation of the temporary pressure reducing station will relieve pressure on the JCSA sewer system during heavy rains helping to reduce the possibility of sewer spills. The Board of Supervisors approved a Special Use Permit ("SUP") in June 2013, authorizing the construction of the facility.

The initial term of the lease agreement between JCSA and HRSD will be 10 years. The SUP conditions for the facility address landscaping, facility color, etc. The property where the proposed facility will be located was purchased by the JCSA in the mid-1980s from the Colonial Williamsburg Foundation. The deed for the property included restrictions relating to what type of facility can be located on the property. The Foundation has agreed to amend the covenants to allow the proposed pressure reducing station.

Following a public hearing, the adoption of the attached resolution authorizing and directing the General Manager to execute any and all documents necessary to amend the deed restrictions and enter into the lease agreement with HRSD is recommended.

The \$1,000 grant reimburses the JCSA for nine percent of the cost of an Alternatives Analysis engineering study, which was required by DCR. The study evaluated three alternatives for renovations needed to meet the Commonwealth's Impounding Structure Regulations and included a cost summary for each alternative. The \$4,000 grant reimburses the JCSA for seven percent of the cost of Renovation Engineering Services to design the selected alternative of adding additional pipes as a secondary spillway. Timmons Engineering performed the Alternatives Analysis study and will design the secondary spillway.

The grants require a 50 percent match. The matching funds for these reimbursement grants were provided in the JCSA's Capital Improvements Program (CIP) budget.

SUBJECT: Transfer of .288-Acre Parcel - Located at 7855 Church Lane - to James City County

The James City Service Authority (JCSA) owns a .288-acre parcel of property identified as James City County Tax Map/Parcel No. 1230100048 located at 7855 Church Lane. A well facility that has not been used in over 15 years is located on the parcel. There are no plans to use the well facility for water production in the future; however, there are plans to convert the facility to a water quality monitoring station.

The JCSA parcel is located immediately adjacent to the Bruton Fire Station. A new fire station is currently being designed at the existing site and will be competitively bid in the very near future. The JCSA parcel, if assembled with existing parcels, will complement the new fire station. The existing well facility can be retained for JCSA use as a monitoring station after transferring to James City County for use with the planned fire station. It is recommended that the parcel be transferred to James City County at no cost to acknowledge the County's after-hours dispatch services.

It is recommended that the Board approve the attached resolution authorizing the General Manager to sign the appropriate documents transferring the parcel to James City County at no costs. The transfer will include an agreement that provides access and egress to the existing well facility to allow the JCSA to use the structure for a water quality monitoring station.
