## **UTILITY PARTICIPATION AGREEMENT -**

## POWHATAN ENTERPRISES, INC.

- WHEREAS, Powhatan Enterprises, Inc., is constructing Phase 6A and 6B of the Powhatan Secondary development, and James City Service Authority (JCSA) engineers have determined that increasing the size and depth of a section of the sewer line serving the area increases the flexibility of providing sewer to adjacent properties; and
- WHEREAS, the modification of the sewer design does not increase the probability of the development of adjoining properties not already slated for development; and
- WHEREAS, Powhatan Enterprises, Inc., has submitted a costs of \$11,100 to complete the proposed modification; JCSA staff has determined the costs to be reasonable and fair.
- NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the James City Service Authority, James City County, Virginia, hereby authorizes the Chairman to sign a Utility Participation Agreement with Powhatan Enterprises, Inc., in the amount of \$11,100.

# RESOLUTION OF APPROPRIATION JAMESTOWN ISLAND WATER SYSTEM BUDGET APPROPRIATION

- WHEREAS, the National Park Service has entered into a contract with the James City Service Authority (JCSA) to administer the construction of a waterline to serve Jamestown Island; and
- WHEREAS, the construction project has been awarded to J. L. Warren, Inc., for a cost of \$460,480; and
- WHEREAS, the National Park Service will reimburse the JCSA for the costs of construction for the project plus a \$25,000 administrative fee.
- NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the James City Service Authority, James City County, Virginia, that the following amounts are hereby adopted and appropriated for the construction of the Jamestown Island Waterline:

## <u>RESOLUTION</u>

#### **UTILITY PARTICIPATION AGREEMENT -**

#### DISTRICT PARK SPORTS COMPLEX WATERLINE

- WHEREAS, the James City County Division of Parks and Recreation is installing a 3,600-foot eight-inch waterline to serve the District Park Sports Complex on Longhill Road; and
- WHEREAS, it has been determined by the James City Service Authority (JCSA) that increasing the waterline to 12 inches will facilitate a second water connection to the Season's Trace water tank and will increase the water system pressures and reliability; and
- WHEREAS, it has been determined that a fair and reasonable costs to increase the waterline size from eight to twelve inches is \$39,812; and
- WHEREAS, Section 29-1 of the <u>Regulations Governing Utility Services</u> allows the JCSA to reimburse a developer for increasing the size of utility infrastructure over what is needed for the development.
- NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the James City Service Authority, James City County, Virginia, hereby agrees to reimburse the James City County (Division of Parks and Recreation) \$39,812 for increasing the size of a waterline in the District Park Sports Complex.

## **D. BOARD CONSIDERATION**

1. <u>Sale of Surplus Property</u>

Mr. Foster stated the three former Sydnor properties were initially owned by the County and have been transferred to the JSCA for disposal and are included in the list of sixteen surplus properties.

Mr. Foster recommended the Board approve the resolution authorizing the General Manager to sell each of the sixteen parcels to the highest bidder, contingent upon the sale price being at least 90 percent of the market value, and preference given: 1) to neighboring property owners; or, 2) to the highest bidder or existing contract purchaser in the case of buildable lots.

Mr. Goodson made a motion to adopt the resolution.

The resolution passed by a unanimous voice vote.

## E. BOARD REQUESTS AND DIRECTIVES

Mr. Foster updated the Board on the water usage rates. The average has been above four million gallons of water per day.

Mr. Harrison inquired about the process for the assessment time of the JCSA's tap fee.

Mr. Foster stated the tap fee is due uniformly when the building permit is issued. There are also fees assessed by other jurisdictions that are incorporated into the tap fee.

A brief discussion followed concerning a possible change to the policy.

Mr. Kennedy requested information on the Service Authority billings.

Mr. Foster stated the JCSA billing should be caught up in September.

Mr. Nervitt made a motion to adjourn.

The motion passed by a unanimous vote.

The James City Service Authority (JCSA) has publicly advertised for competitive bid the plans and specifications to upgrade and improve a well facility (W-1) located adjacent to Owens Brockway in the Hankins Industrial Park in Toano. The improvements generally include the modifications necessary to convert the well facility to a water production facility that blends water from the Chickahominy Piney Point and Potomac Aquifers. The well has previously only produced water from the Chickahominy Piney Point Aquifer. The production capacity will increase from 350 to 1,050 gallons per minute without increasing the withdrawal from the Chickahominy Piney Point Aquifer, the smaller and more vulnerable aquifer. The W-1 Well Facility improvements are the last major water production increases provided for under the JCSA's current Groundwater Withdrawal Permit issued by the Department of Environmental Quality.

Two firms submitted bids on the project as follows:

T. A. Sheets, Inc., has performed similar type work for the JCS A before and has therefore been determined a qualified bidder capable of performing the required construction. There are funds in the budget to cover the costs of the project and the bid is within the engineer's \$950,000 estimate.

Staff recommends the Board approve the attached resolution awarding the W-1 Well Facility Improvements bid (Bid Number 01-B-0015) improvements to T. A. Sheets, Inc., in the amount of \$872,000.
