The Board and staff discussed the well levels, locations of well failures, costs covered by the JCSA for well failures attributed to JCSA well impacts, and the trend in number of claims.

The Board requested a report of claims for the past five years.

Mr. Goodson inquired if directional drilling is possible with work associated with road repairs.

Mr. Foster stated that due to the nature of this work and existing utilities, directional drilling is not an option with this project.

Mr. Goodson made a motion to adopt the items on the Consent Calendar.

Mr. Wanner inquired if the Virginia Department of Transportation has changed its roadway repair standards.

Mr. Foster stated that in the past, the James City Service Authority has not been held strictly to the standards until the last six months. Now everybody in the Williamsburg Residency is being held strictly to the standard.

SUBJECT: Sale of Property - 2888 Jonas Profit Trail - Fernbrook

Mrs. Carol Grabowski has identified that a very small portion of her driveway was constructed on property owned by the James City Service Authority and used for a sewerage pumping station. The encroachment does not impact the JCSA's operation of the pump station.

Mrs. Grabowski has submitted a letter expressing her interest in purchasing a small portion of the JCSA property to clear the title of her property. The Office of Real Estate Assessment performed an appraisal establishing a fair market value of \$550 for the portion of the property desired by Mrs. Grabowski. A copy of a map depicting the area desired to be purchased is attached.

Since the sale of the property to Mrs. Grabowski will not impact the JCSA's ability to operate the sewerage pumping station, and will assist a customer in clearing the title to her property, it is recommended that the Board approve the attached resolution authorizing the General Manager to sign the necessary documents to sell the property for \$550.

SALE OF PROPERTY - 2888 JONAS PROFIT TRAIL - FERNBROOK

- NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the James City Service Authority, James City County, Virginia, authorizes the sale of the property as requested and directs the General Manager to sign all necessary documents to accomplish the sale.
