SUBJECT: Award of Bid - Toano Force Main

The plans and specification for installation of a sewer force main from Toano to Anderson's Corner have been publicly advertised and competitively bid. The force main will redirect the wastewater that currently follows east along Route 60 through a series of sewerage pumping stations. Upon the completion of this project, the sewage from the pump station adjacent to Owens Brockway will be pumped west along Route 60 to the Hampton Roads Sanitation District (HRSD) force main located in Rochambeau. The project, which was recommended by the Master Infrastructure Plan, will eliminate multiple pumping of the wastewater reducing demands on the current system. Eleven firms submitted bids ranging from \$293,857.53 to \$743,306. The results of the bids are as follows:

The low bid submitted by C.D. French Excavating Contractors was close to the design engineer's estimate of \$300,000. It is also within appropriations and funds are available in the Capital Improvement Plan budget. A review of references indicates the firm is capable of performing the work associated with the project.

Staff recommends that the Board approve the attached resolution awarding the Toano Force Main to C.D. French Excavating Contractors for a contract amount of \$293,857.53.

SUBJECT: Water Conservation Committee Appointments

Three years ago the Board appointed seven members to the newly established Water Conservation Committee. The Committee's purpose was to provide guidance to staff and the Board on encouraging citizens to conserve water. The Committee's efforts have been very successful. Since its appointment, the JCSA has employed a full-time Water Conservation Coordinator and established the "Let's Be Water Smart" program. The Committee has been invaluable in its guidance and assistance to staff during last summer's water restrictions.

The terms of the original appointees will soon expire. In addition, three members have been appointed to fill vacancies on the Committee. Unfortunately, the expiration of the term of the members appointed to fill unexpired terms is not clearly defined.

The members of the Committee are as follows: Richard Costello, Willard "Skip" Morris, Tom Belden, Sarah Kadec, Louise Meneges, Anderson Bradshaw, and Margaret Mondul.

All of the current members of the Water Conservation Committee have agreed to accept reappointment. To simplify our record keeping on the terms of appointment. It is recommended that the Board reappoint all of the current members of the Water Conservation Committee for a three-year term expiring on April 1, 2006.

SUBJECT: Award of Bid - Groundwater Treatment Facility

The plans and specifications for the Groundwater Treatment Facility have been publicly advertised for competitive bid. The bids were opened on March 11, 2002. Three firms submitted bids as follows:

Mid Eastern Builders, Inc.\$10,100,000Oyster Point Construction10,443,227Henderson, Inc.10,680,954

The low bid submitted by Mid Eastern Builders, Inc., is below the \$12,000,000 estimate prepared by the design engineer. Mid Eastern has been determined capable of performing the work associated with the project and is currently in the final stages of constructing a similar facility for Gloucester County, Virginia. The project will be partially financed with bonds that will be issued in late April. Therefore, funds will be available for the project when needed.

Staff recommends that the Board approve the attached resolution awarding the construction contract for the Groundwater Treatment Facility to Mid Eastern Builders for a bid amount of \$10,100,000.


