SUBJECT: Contract Award – Manhole and Wet Well Rehabilitation and Related Services

A Request for Proposal (RFP) was solicited from qualified firms to provide manhole and wet well rehabilitation and related services, as determined necessary by the James City Service Authority (JCSA) to fulfill certain requirements of JCSA's Consent Order with the Virginia Department of Environmental Quality to address sewer system overflows.

Eight firms responded to the RFP by describing their interest, qualifications, project approach, and experience in performing similar work. A team of staff members representing the JCSA and the James City County Purchasing Division evaluated the proposals submitted by eight firms and selected the three top-ranked firms to continue the evaluation process. Two firms were selected to be awarded contracts. The contracts have an initial term of one year with the option of up to four one-year renewals. The RFP included cooperative procurement provisions allowing other entities to use the contracted firms if they so choose.

Firms selected and recommended for contract award are as follows:

- Lyttle Utilities, Inc.
- ACTS Group, LLC

During the first year of the contract, JCSA Engineering staff estimates 80 manholes will be rehabilitated for approximately \$328,000 and three wet wells will be coated at a cost of \$160,000.

Staff recommends approval of the attached resolution awarding a contract to the firms listed above.

SUBJECT: Wellhead Protection Grant Supplemental Award – Virginia Department of Environmental

Quality and Virginia Department of Health – \$15,000

The James City Service Authority (JCSA) has been awarded a \$15,000 supplement to the original Wellhead Protection Grant of \$15,000 that was appropriated by the Board of Directors on June 26, 2012. The supplement and the original grant were awarded by the Virginia Department of Environmental Quality and the Virginia Department of Health. The funding sources are the Federal Safe Drinking Water Act and the Virginia Drinking Water State Revolving Fund Set-Asides.

The funds are to be used to properly abandon old, unused wells through the JCSA's Cap It Well Abandonment Program. Wells are abandoned when they are replaced by new wells or when homes are connected to the JCSA. Virginia law requires that private wells no longer in use be properly abandoned, which means that a licensed well driller permanently seals or "caps" the well. The Cap It program provides funding and information to assist citizens in capping wells.

The purpose of the Cap It Program is to protect James City County's groundwater resources from pollutants and contamination via unused or improperly abandoned private wells in James City County, protect the Chesapeake Bay and local rivers and watersheds by reducing the threat of groundwater contamination, and reduce the threat to humans and animals that may become trapped in an open, unused well.

Over the past 10 years, 265 wells have been abandoned through this program. County residents and businesses are eligible for the program with residential applications taking priority. The program had a waiting list of 13 applications when the original grant was appropriated and three additional applications have subsequently been received. Ten wells were abandoned under the original grant. The supplement will finance abandonment of the remaining six wells on the waiting list and funds will likely remain to process several future applications.

The grant supplement requires no match.

Staff recommends adoption of the attached resolution.

SUBJECT: Contract Award - Indigo Dam Road, Jamestown Road, and Lake Drive Water Main

Improvement Projects

The purpose of the Indigo Dam Road, Jamestown Road, and Lake Drive Water Main Improvement Projects is to replace aging pipes that have reached the end of their life cycle. The deteriorated condition caused pipe failures over the past several years.

The Indigo Dam Road Project consists of replacing 1,825 linear feet of the existing 12-inch water main along Indigo Dam Road from Ironbound Road to the end of the cul-de-sac. The Jamestown Road Project consists of replacing 2,582 linear feet of the existing 12-inch water main along Jamestown Road from the vicinity of Raleigh Square to Neck-O-Land Road. The Lake Drive Project consists of installing 374 linear feet of the 8-inch water main in the shoulder of Lake Drive. The attached maps illustrate the project areas.

The contractor shall complete all three projects within 270 days. Work on Indigo Dam Road will be completed first. Traffic in the construction areas will be reduced to one lane at times, but emergency vehicle access will be maintained at all times. The JCSA's Project Manager will coordinate with the contractor to minimize lane closures.







SUBJECT: Authorization to Retire 2003 Bond Debt from James City Service Authority (JCSA) Fund

Balance

In 2003 the Board authorized the James City Service Authority (JCSA) to issue bonds with a 15-year term in the amount of \$14,650,000 to finance the construction of the Five Forks Groundwater Treatment Plant. The bonds were issued at an interest rate of approximately 5.0 percent. Annual principal and interest payments are approximately \$1.4 million. The bond indenture agreement precluded the JCSA from refinancing the bonds for ten years after the bonds were issued and requires a 1.0 percent penalty for any redemption for the first year after they are redeemable. The first date the bonds can be retired is January 15, 2013. Redemption of the bonds at the earliest date possible will require a \$7,237,671 payment, which includes \$1,207,971.88 included in the FY 12 budget and will be due on January 15, 2013, regardless of whether the bonds are refunded.

Recent interest rates on revenue bonds for organizations like the JCSA are in the 1.75-2.00 percent range. Refinancing the 2003 bonds would likely save the JCSA approximately \$350,000 in debt service costs over the remaining five years of the bond term.

The JCSA currently has approximately \$32.8 million in its fund balance that is generating less than one percent in interest returns on investments or an annual return of approximately \$10,000 per \$1.0 million invested. Improvements in investment returns are not anticipated in the intermediate future. Approximately \$12.3 million of the \$32.8 million fund balance is committed to previously approved projects, leaving an uncommitted balance of \$20.5 million that could be used to retire the balance of the 2003 bonds. The use of \$6,029,700 from the uncommitted balance of \$20.5 million will drop the fund balance to \$14.5 million or approximately 83 percent of revenues from a high of 198 percent over the last ten years. The JCSA's debt coverage ratio would improve from 1.17 to 2.14 within the desired range of greater than 1.5 recommended by the rating agencies that evaluate the JCSAs credit. Using the uncommitted fund balance to retire the 2003 bonds will result in a net debt service savings of approximately \$600,000. Reduced expenditures from the elimination of the bond payments would be used to replenish the JCSA fund balance.

Staff recommends approval of the attached resolution authorizing the use of uncommitted fund balance in the amount of approximately \$6.0 million to retire the 2003 bonds at the earliest date possible.
