Subject: Emergency Purchase Order Change Order - Groundwater Treatment Facility - Pump and Motor Assembly Retrieval, Removal, and Reinstallation - \$101,547

Action Requested: Shall the Board approve the resolution authorizing the Emergency Purchase Order Change Order to A.C. Schultes of Maryland, Inc. for the James City Service Authority (JCSA) Groundwater Treatment Facility Lower Potomac Production Well #1 (LP 1) Pump and Motor Assembly Retrieval, Removal, and Reinstallation in the amount of \$101,547?

Summary: Purchasing regulations require Board approval for a change order greater than \$50,000 to Emergency Purchase Order 313041.

In late March, the pump and motor assembly in LP 1 failed and fell hundreds of feet in the well. Emergency Purchase Order 313041 was issued March 28, 2013, to A.C. Schultes of Maryland, Inc. in the amount of \$49,700 for the removal and reinstallation of the assembly.

The emergency purchase order price was based on a recent competitive sealed bid for the removal and reinstallation of an assembly that had failed in place but had not fallen. Additional time was required to establish the full extent of the specialized services required for the retrieval of the assembly from the bottom portion of the LP 1 well. The original emergency purchase order required a \$101,547 change order that was issued on May 8, 2013. The change order included additional time for the prime contractor, additional regular crane rental, additional TV inspections, specialized sub-contracted retrieval services, and rental of a massive 75-ton crane required for jacking.

In late March, the pump and motor assembly in Lower Potomac Production Well #1 (LP 1) at the Groundwater Treatment Facility failed and fell hundreds of feet in the well. Emergency Purchase Order 313041 was issued March 28, 2013, to A.C. Schultes of Maryland, Inc. in the amount of \$49,700 for the removal and reinstallation of the assembly.

The emergency purchase order price was based on a recent competitive sealed bid for the removal and reinstallation of an assembly that had failed in place but had not fallen. Additional time was required to establish the full extent of the specialized services required for the retrieval of the assembly from the bottom portion of the LP 1 well. The original emergency purchase order required a \$101,547 change order that was issued on May 8, 2013. The change order included additional time for the prime contractor, additional regular crane rental, additional TV inspections, specialized sub-contracted retrieval services, and rental of a massive 75-ton crane required for jacking.

Purchasing regulations require Board approval for any change order greater than \$50,000 to Emergency Purchase Order 313041.

Staff recommends approval of the attached resolution authorizing the change order for LP 1 Pump and Motor Assembly Retrieval, Removal, and Reinstallation to A.C. Schultes of Maryland, Inc. for \$101,547.
