The purpose of the Tarleton Bivouac Sewer Reconstruction Project is to replace aging sewer pipes and service lines that have reached the end of their life cycles. The work consists of the replacement of approximately 463 linear feet of 8-inch sewer line with polyvinyl chloride. Related sewer manholes, laterals, and cleanouts will also be replaced.

The Invitation for Bids was publicly advertised and competitively bid. Five bids were received as follows:

Calfee Contracting	122,507.00
Tidewater Utility Construction, Inc.	178,490.55
Basic Construction	190,543.24
Henry S. Branscome, LLC	220,085.80

LLaRS, Inc. was determined to be the lowest responsive and responsible bidder and provided satisfactory references, bonds, and proof of required insurance coverage.

The bid is consistent with the engineer's estimate and adequate funds are available in the James City Service Authority Capital Improvements Program budget for this project.

Staff recommends approval of the attached resolution awarding the contract for the Tarleton Bivouac Sewer Reconstruction Project to LLaRS, Inc. for \$103,525.



Tarleton Bivouac Sewer Reconstruction


