 - a. Members are not required to obtain the floor before making motions or speaking, which they can do while seated.
 - b. Motions need not be seconded.

 - d. Informal discussion of a subject is permitted while no motion is pending.

SUBJECT:	Contract Award - Lift Station 4-7 Control Building Replacement

The purpose of the Lift Station 4-7 Control Building Replacement Project, located at 4604 John Tyler Hwy. near Five Forks, is to provide flood protection for the sewage lift station control building. James City Service Authority's sewage Lift Station 4-7 has flooded several times causing damage to the equipment and wastewater overflows. The control building houses pumps, electrical motors, electrical controls and equipment, an emergency generator and indoor fuel tank. To alleviate the problem, JCSA is proposing to construct a flood proof control building to a height above the maximum recorded flood level. The building will be equipped with a watertight access door and ventilation louvers will be positioned above the flood level so the station can remain operable during flood conditions.

The Invitation for Bids was publicly advertised and competitively bid. Three bids were received as follows:

David A. Nice Builders, Inc.	\$ 333,000
R.E.W. Corporation	368,333
Shaw Construction	399,400

David A. Nice Builders, Inc. was determined to be the lowest responsive and responsible bidder and provided satisfactory references, bonds and proof of required insurance coverage.

Adequate funds are available in the JCSA Capital Improvements Program budget for this project. Staff recommends that the Board approve the attached resolution awarding the contract for the Lift Station 4-7 Control Building Replacement Project to David A. Nice Builders, Inc. for \$333,000.



Surber Development and Consulting, LLC proposes to develop a 148-unit senior living apartment complex at 6300 Old Mooretown Rd. in York County. They are requesting permission to connect to the existing James City Service Authority (JCSA) sewer line. Since this parcel is located in York County and the proposed development will likely require more than 30,000 gallons per day of sewer service, the approval of the Board of Directors is required.

The development has obtained all necessary approvals from York County and York County has provided a letter stating they do not object to JCSA providing sewer service to the parcel.

Under current standards, sufficient capacity exists to accommodate this development. Therefore, staff recommends approval of the request.

It should be noted that the Hampton Roads Sanitary District is developing new standards to determine capacity. If the new standards are developed and implemented before this development begins construction and sufficient capacity does not exist under the new standards, it is possible that this development would have to construct improvements to address the capacity.


REQUEST FOR PERMISSION TO CONNECT TO SEWER SYSTEM


