I. GENERAL MANAGER'S UPDATE

1. Dashboard Report - March 2022

Mr. Powell noted he had one item. He further noted the dashboard reflected a substantial reduction in residential delinquencies for the month as a result of American Rescue Plan Act (ARPA) funds. Mr. Powell stated the ARPA funds were being administered in the current billing cycle, adding the entire \$240,000 funds were administered. He noted Hampton Roads Sanitation District (HRSD) contributed \$5,000-\$6,000 in additional funding for customers. Mr. Powell further noted all of both the Coronavirus Aid, Relief, and Economic Security (CARES) Act and ARPA funds had been applied on behalf of the eligible customers who had applied for assistance. He added disconnection for non-payment would resume since the CARES Act and ARPA funds had been used. Mr. Powell noted there had been no disconnection for non-payment over the past two years. He further noted the Board had authorized disconnections for non-payment several months earlier, but the James City Service Authority (JCSA) had delayed that action until the funds were administered. Mr. Powell stated JCSA was one of the last, if not the last, regional public utility to do so with disconnections.

Mr. McGlennon asked how many customers were in arrears on payments and if some people had not taken advantage of the assistance program.

Mr. Powell noted with the latest opportunity, a formula had been applied to all eligible customers. He further noted no application process had been implemented during that phase. Mr. Powell stated the number of customers in arrears was listed on the dashboard report. He added the \$240,000 had assisted over 1,100 customers.

Ms. Larson and Mr. McGlennon noted that was great news.

Ms. Larson stated the payment options of PayPal and Venmo on the latest bill. She noted the

options available for customer payment. Ms. Larson thanked Mr. Powell for the update.

A Request for Proposals (RFP) for Grounds Maintenance Service for Lift Stations and Wells was publicly advertised. Four firms responded to the RFP by describing their qualifications, experience in performing similar work, available equipment, and proposed pricing. A team of staff members representing the James City Service Authority (JCSA) and the James City County Purchasing Division evaluated the proposals. Based on the criteria listed in the RFP, the Evaluation Committee selected RSG Landscaping, LLC, as the most fully qualified firm that best met JCSA's needs as defined in the RFP. RSG Landscaping, LLC, has successfully completed similar work for other government entities including the City of Charlottesville Department of Public Utilities and the City of Lynchburg Public Works.

An initial one-year contract term was negotiated with RSG Landscaping, LLC, for \$102,607. The contract has an initial term of one year and contains the option for five additional one-year renewal periods upon mutual agreement of both parties.

Staff recommends the Board approve the attached resolution authorizing award of the contract for Grounds Maintenance Service for Lift Stations and Wells to RSG Landscaping, LLC, for \$102,607.

Sewer Pipes

The James City Service Authority (JCSA) has approximately 132 miles of 8- to 18-inch "cross country" gravity sanitary sewer pipes located in easements without public or private roads for vehicular traffic. JCSA's Virginia Department of Environmental Quality Consent Order Management, Operation and Maintenance program requires regular internal television inspection for these pipes at least every 15 years to identify blocked and damaged areas that require repairs.

A Request for Proposals (RFP) was publicly advertised for qualified and experienced firms to perform the inspection work. Six firms responded to the RFP by describing their qualifications, experience in performing similar work, equipment, and proposed pricing. A team of staff members representing JCSA and the James City County Purchasing Division evaluated the proposals. Based on the criteria listed in the RFP, the Evaluation Committee selected East Coast Infrastructure, Inc., McKim & Creed, Inc., and Tri-State Utilities as the most fully qualified firms that best met JCSA's needs as defined in the RFP. East Coast Infrastructure, Inc. and Tri-State Utilities have completed satisfactory work for JCSA and McKim & Creed, Inc. have successfully completed similar work for other government entities including Fort Eustis.

The initial contract term is two years with the option of four additional one-year renewals upon mutual consent of the parties. Individual project assignments will consist of inspecting quantities of approximately 30,000 linear feet. A purchase order will be issued for each individual project assignment and will reference the contract terms and conditions. Job costs will be calculated using the negotiated linear foot and cleaning prices listed in the table below.

Lift Station 2-4, located at 75 Jan Rae Circle, serves the Windy Hills Mobile Home Park, the Virginia Peninsula Regional Jail, and the Merrimac Juvenile Detention Center, and has the third highest wastewater flows in the James City Service Authority's (JCSA) wastewater collection system of 77 lift stations. Many of the station's building systems and equipment are at the end of their service lives and require replacement to maintain service levels, mechanical efficiency, and safety.

Scheduled rehabilitation work consists of upgrading the electrical system including the generator and the variable frequency drive (VFD), the hardware and software package that controls electric motor speed and power in pump and motor assemblies; replacing the original pump and motor package; replacing all the suction and discharge piping; and installing a new bar screen vault.

Due to the increasingly long lead times and material shortages associated with the global pandemic, Engineering staff determined directly purchasing the pump and motor package was the most efficient procurement method to guarantee availability due to the current lead time of 18 to 20 weeks. The remainder of the rehabilitation work will be competitively procured in the near future.

Engineering staff researched the limited number of pump and motor vendors able to supply the vacuum primed pumps required at Lift Station 2-4 that meet JCSA design standards. A sole source purchase of a Smith & Loveless series mounted vacuum primed pump and motor package consisting of four assemblies from Commonwealth Engineering & Sales, Inc. was determined to provide the best value and best meet JCSA's needs for this project. Commonwealth Engineering & Sales, Inc. is Smith & Loveless' authorized distributor in JCSA's geographic area and has successfully completed JCSA projects in the past.

Compared to other possible options, the Smith & Loveless package is more mechanically efficient, easier to access and maintain, less prone to mechanical failure because it contains fewer moving parts, safer for staff to service, able to accommodate above ground rather than underground piping, and occupies less space on the facility floor.

Staff negotiated a turnkey package of \$270,267 with Commonwealth Engineering & Sales, Inc. to provide all required material and equipment to furnish the replacement pump and motor package. To obtain the best value and ensure the negotiated package met all the Authority's needs, staff researched current technology, developed budget estimates, and conducted a site visit with the vendor. The price has been determined to be fair and reasonable through comparison with previous similar installations and budget estimates.

The current Capital Improvements Program budget contains funding to replace the pump and motor package. Staff recommends adoption of the attached resolution authorizing the \$270,267 sole source purchase from Commonwealth Engineering & Sales, Inc. to furnish the Lift Station 2-4 pump and motor package.

- WHEREAS, the original Lift Station 2-4 pump and motor package is at the end of its service life and requires replacement with a Smith & Loveless series mounted vacuum primed pump and motor package to maintain service levels, mechanical efficiency, and safety; and
- WHEREAS, Commonwealth Engineering & Sales, Inc. is Smith & Loveless' sole distributor in the James City Service Authority's geographic area authorized to furnish the pump and motor package, and staff negotiated a price of \$270,267 with Commonwealth Engineering & Sales, Inc. to furnish the replacement package.
- NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the James City Service Authority, James City County, Virginia, hereby authorizes the sole source purchase from Commonwealth Engineering & Sales, Inc. to furnish the replacement pump and motor package at Lift Station 2-4.






Water Service Revenue




Water Service Revenue through March




Sewer Service Revenue




Sewer Service Revenue through March




Water Tap Fees




Water Tap Fees through March




Sewer Tap Fees








Monthly Water Production




Water Production through March







Commercial Consumption




Residential Consumption




Delinquent Commercial Accounts Over \$500 and Over 90 Days
