SUBJECT: Contract Award - Audit Services

A Request for Proposals (RFP) was publicly advertised for qualified and experienced firms to perform Audit Services for James City Service Authority (JCSA), James City County, Williamsburg-James City County Schools, and several other entities where James City County serves as the fiscal agent.

Four firms responded to the RFP by describing their qualifications, experience in performing similar work, methodology, schedule, and proposed pricing. A team of staff members representing JCSA, James City County, Williamsburg-James City County Schools, and the James City County Purchasing Division evaluated the proposals. Based on the criteria listed in the RFP, the Evaluation Committee selected Cherry Bekaert as the most fully qualified firm that best met JCSA's needs as defined in the RFP. Cherry Bekaert has successfully completed audit engagements for a significant number of Virginia counties, cities, and school divisions and the firm received satisfactory professional references.

A five-year contract with an initial annual fee of \$24,800 for JCSA's audit was negotiated with Cherry Bekaert. The contract contains the option for five additional one-year renewals. The estimated value of all possible contract years is over \$100,000 and requires Board approval for contract award.

Staff recommends adoption of the attached resolution authorizing award of the Audit Services contract to Cherry Bekaert.

SUBJECT: Contract Award - Water Tank Engineering Services

A Request for Proposals (RFP) was publicly advertised for qualified and experienced firms to perform Water Tank Engineering Services for all of James City Service Authority's (JCSA) elevated ground and pressure water storage tanks. The JCSA has 39 water storage tanks ranging in size from 5,000 to 1.25 million gallons. The scope includes inspections, rehabilitation, or repair design assistance, and updating the JCSA's long-term Tank Maintenance Plan.

Six firms responded to the RFP by describing their qualifications, experience in performing similar work, methodology, and proposed pricing. A team of staff members representing the JCSA and the James City County Purchasing Division evaluated the proposals. Based on the criteria listed in the RFP, the Evaluation Committee selected Tank Industry Consultants as the most fully qualified firm that best met JCSA's needs as defined in the RFP. Tank Industry Consultants has previously completed satisfactory tank evaluation work for JCSA.

An initial one-year contract containing a time and materials rate schedule was negotiated with Tank Industry Consultants. The contract contains the option for four additional one-year renewals. A purchase order referencing the contract terms and conditions will be issued for each individual project. Project costs will be calculated using the negotiated rate schedule. The estimated value of all possible contract years is over \$100,000 and requires Board approval for contract award.

Staff recommends adoption of the attached resolution authorizing award of the Water Tank Engineering Services contract to Tank Industry Consultants.







Water Service Revenue




Water Service Revenue through March







Sewer Service Revenue through March




Water Tap Fees




Water Tap Fees through March




Sewer Tap Fees




Sewer Tap Fees through March




Monthly Water Production




Water Production through March







Commercial Consumption




Residential Consumption






Delinquent Residential Accounts Over \$300 and Over 90 Days
