SUBJECT: Renewal of Cellular Contract on Warhill Water Tower, Lease Amendment - Water Tower

at 5900 Warhill Trail

New Cingular Wireless PCS, LLC ("New Cingular") currently leases space on top of the James City Service Authority's (the "JCSA") water tower situated on the Warhill property and the lease expires in 2025. New Cingular has requested that the JCSA renew the lease for an additional 15 years. The proposed lease extension increases the yearly rent from \$42,000 per year to \$60,000 per year with a 3% yearly increase plus a \$30,000 administrative fee to be paid to the JCSA upon ratification of the lease extension. The proposed terms also allow New Cingular to increase the amount of equipment on the water tower up to an additional 20% load without additional charge if the JCSA agrees that the proposed addition will not negatively affect the water tower. Staff from the JCSA have reviewed the proposed extension terms and are in agreement with them.

I recommend that the Board approve the attached resolution authorizing the General Manager to execute those documents necessary to extend New Cingular's lease on the Warhill water tower.

RENEWAL OF CELLULAR CONTRACT ON WARHILL WATER TOWER,

LEASE AMENDMENT - WATER TOWER AT 5900 WARHILL TRAIL

- WHEREAS, the James City Service Authority (the "JCSA") owns a parcel of property located at 5900 Warhill Trail and further identified as James City County Real Estate Tax Map Parcel No. 3210100012B (the "Property"); and
- WHEREAS, New Cingular Wireless PCS, LLC ("New Cingular") and the JCSA entered into a Lease Agreement dated March 24, 2000, as amended by that certain First Amendment to Lease Agreement dated April 15, 2008, and as further amended by that certain Second Amendment to Lease Agreement dated November 11, 2022 (collectively, the "Lease"), each of which authorized the placement of a cellular array upon the JCSA's water tower located on the Property; and
- WHEREAS, the Lease expires in 2025 and New Cingular desires to extend the Lease for an additional 15 years and to further amend certain other terms of the Lease, including the increase in rent amount to \$60,000 per year with a 3% yearly escalation, a one-time administrative fee of \$30,000 to be paid upon execution of the Lease extension, and the ability to place additional equipment on the water tower up to an additional 20% load upon the JCSA's approval and without additional cost to New Cingular; and
- WHEREAS, a public hearing was advertised and held regarding extension and amendment of the terms of the Lease; and
- WHEREAS, the Board is willing to amend the Lease in consideration of additional rent and subject to certain terms.
- NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the James City Service Authority, James City County, Virginia, that the General Manager is authorized and directed to execute those documents necessary to amend the Lease terms as generally set forth herein.

SUBJECT: Formal Acceptance of Water and Sewer Systems - Fiscal Year 2024

Attached is a resolution formally accepting water and sewer systems constructed and contributed to the James City Service Authority (JCSA) by developers during Fiscal Year (FY) 2024. The resolution lists the value of the infrastructure at the time of completion. The total value of \$6,520,060 will be included in the net capital asset calculations for JCSA's FY 2024 Annual Comprehensive Financial Report pending the Board of Directors' acceptance of the systems. JCSA had net capital assets totaling \$157,188,092 in the FY 2023 Annual Report.

Staff recommends adoption of the attached resolution accepting the dedication of the infrastructure.







Water Service Revenue




Water Service Revenue through March







Sewer Service Revenue through March




Water Tap Fees




Water Tap Fees through June




Sewer Tap Fees




Sewer Tap Fees through June




Monthly Water Production



Water Production through June








Commercial Consumption




Residential Consumption
