MEMORANDUM

DATE: January 21, 1991

TO: The Board of Supervisors

FROM: David B. Norman, County Administrator

SUBJECT: Citizen Involvement - County Financial Planning

To enhance citizen involvement in setting priorities and in exploring revenue options, both long-term and short-term, I recommend the creation of a Citizens Financial Planning Task Force. The purpose of the task force would be to participate in the current budget process, evaluate policy recommendations, needs and priorities and to increase overall citizen involvement in financial planning.

During the FY 1993 budget process, the Task Force may familiarize itself with the budget process and information, and make suggestions and recommendations to the Board as it deems appropriate. At its first worksession on the FY1993 budget, the Board will meet with the Task Force to hear the opinions of the members. The major charge to the Task Force will be to make a final report before the end of September, providing recommendations to improve the budget process and substance in the future. The Task Force would end on September 30, 1992.

I would recommend the following appointment process. Each Board member would be asked to submit nominees for appointment to Mari Lou Smith by January 29. You can submit as many nominees as you wish. Staff may add names to the list of individuals we believe to be interested. Mari Lou would then compile the names and distribute them to the Board in its agenda package for the February 3rd meeting. On that date the Board would select seven as Task Force members, with some alternates in case one or more of your top seven cannot serve. The County's Budget staff would act as staff and Sandy Wanner would be the Administrative designee as a non-voting member of the Task Force.

As another component of our efforts to increase citizen involvement in the budgetary process, we would propose that the Board sponsor a "town meeting", open to all citizens, but with special invitiations to residents known to be interested in the budget, taxes or programs. The town meeting would consist of a brief introduction by staff of the probable budget scenario (increasing spending, mandates, declining State assistance, little local revenue growth, etc) for FY1993 and beyond.

In small group sessions, the attendees would then be asked to comment directly on expectations and recommendations to address the probable scenario. All efforts will be made to solicit suggestions for improvement, innovation, defining priorities and expanding the list of possible options. We would anticipate about a two-hour process with a concluding presentation of some of the small group ideas to the larger group.

I would envision that each of the small groups would have at least one Board member or key staff representative whose responsibility it would be to listen. A facilitator would actually conduct the meeting.

By videotaping excerpts of the small group sessions and later broadcasting them, we should be able to inspire a continued public discussion about the County's needs, priorities and resources.

I believe these two initiatives, the Citizen Task Force and the Town meeting, will complement the existing public information efforts during the budget process. Your approval of this initiative is recommended.

Statement on the Size of the James City Planning Commission

The Planning Commission is one of the most important parts of the James City County government. It advises the Board of Supervisors on land use matters, in addition to its role in implementing land use policies. It plays a particularly important role as the County grows and changes.

Members of the James City Board of Supervisors have believed for some time that boards and commissions responsible for making decisions are likely to function better if they are not large. Most decision—making County committees follow this pattern:

7 members — Industrial Development Authority

5 members — Wetlands Board

8 members — Library Board (joint board with Williamsburg)

7 members — Parks and Recreation Commission

Perhaps the best comparison for the Planning Commission is the School Board. A few years ago it had 10 members: then it went to 9 members: now it is 8 members; and it will go to 7 members in 1993. That includes members from both James City County and Williamsburg.

We plan to phase the changes so that the Commission will change from 11 members in 1991 to 9 members in 1992 and 1993; to 8 members in 1994; and finally to 7 members in 1995. At that point there will be one member from each of the five districts, plus two members chosen at-large. The phasing will prevent the Commission from losing too much of its talent at one time. A membership of 7 should be both efficient and effective.

This is a long-range effort to bring the Commission to a better size, one that is similar to other boards in our government as well as similar to planning commissions in most comparable communities. We think it will permit the Commission to function even more effectively on behalf of the community.

The Board of Supervisors has agreed upon the following plan for future appointments.

1992

The Board will fill vacancies in Roberts and Jamestown but not in Powhatan, and will not appoint a representative from the Board itself.

The result is a total of <u>nine</u> members. Membership consists of:
