B. MOMENT OF SILENCE

Mr. Goodson requested that the Board and citizens observe a moment of silence.

C. PLEDGE OF ALLEGIANCE

Cailin and Ethan Agnello, students at Rawls Byrd Elementary School, led the Board and citizens in the Pledge of Allegiance.

D. PRESENTATIONS

1. <u>Sentara Williamsburg Community Hospital Block Buddies Program – 2005 Spirit of Caring Award</u>

Mr. Goodson accepted a plaque from Mr. Bob Graves, Sentara Williamsburg Community Hospital ("Hospital"), in recognition of the partnership between the County and the Hospital for the award-winning Block Buddies Program.

Mr. Graves stated that the Hospital received the **2005** Healthy Communities Planetree Spirit of Caring Award for the Block Buddies Program, provided an overview of the Program which was established in 1998 as a Healthy Promoter Program for identified at-risk neighborhoods in the Greater Williamsburg area, recognized members in the audience who participate in the Program's success, and showed a video of the Block Buddies Program that will be aired on the Government Channel.

Mr. Goodson inquired where the video would be aired and how the word got out about the Program.

Mr. Graves stated the first formal recognition of the Program took place at a national meeting of the Planetree organization where the Program was highlighted before a large audience.

Mr. Bradshaw thanked the Hospital for the partnership and stated that the Program has grown and changed over the years.

Mr. Bradshaw requested an update on the new Williamsburg Sentara Hospital facility

Mr. Graves stated that the facility is being constructed on schedule and within budget, the hospital is slated to be opened and patients transferred on August 17, and stated that on August 12 there will be a VIP reception and ribbon cutting that the Board will be invited to attend.

2. <u>Virginia Performance Measures Consortium Update</u>

Ms. Rona Vrooman, Training and Quality Performance Coordinator, made a presentation to the Board regarding the Virginia Performance Measures Consortium including an overview of the consortium membership, purpose of the performance measurements, and how the information will be utilized to provide citizens information about how their government is doing; that staff can compare services internally and externally, the Board can plan and allocate resources; and also provided an overview of the timeline for the release of the report regarding the collected data.

Mr. Bradshaw inquired if the measures can be reviewed and determined what measures apply to the County and the goals of the County.

Mr. Harrison requested that when the measures are reviewed for applicability to this community, the County include those measures that focus on housing issues.

Ms. Vrooman stated that although the County is in the initial stages of the first run of data collection, the County will have the opportunity to review the information to identify what material is beneficial to the County in moving forward with the goals of the County.

3. Colonial Services Board – Introduction of Dr. Dennis Wool. Executive Director

Dr. Dennis Wool, Executive Director of the Colonial Services Board, provided an overview of his qualifications and experiences that will complement the services offered by the Colonial Services Board, and he commented on the initiatives of the partnerships to provide quality service to those who are in need.

Mr. Bradshaw stated that the Colonial Services Board has offered successful programs and thanked Dr. Wool for his enthusiasm to meet challenges, even those of budgeting, while the higher levels of Government are implementing funding cuts to programs such as these.

E. PUBLIC COMMENT

1. Mr. Ed Oyer, 139 Indian Circle, commented on an article in a local paper regarding student population in schools and inquired who is wrong in the estimate of student population – the developer or the School Division; inquired why staff presents off-budget items, stated that traffic in New Town is not in compliance with the initial traffic design plans that identified 14 traffic lights for New Town; and stated that in October of 1998 Mr. Bradshaw said that *he favored cluster housing in the A-I zone topreserve greenspace*, yet there is still more density per acre than present zoning as it exists.

Mr. Bradshaw stated that at the last meeting Mr. Over called attention to the Poquoson school system and elementary school development which will be completed on time and on budget at \$15,500,000 and

inquired why the County cannot do that; he talked with Dr. Lewis at Poquoson Schools regarding the inquiry and gathered further information including that the school will house Grades 3, 4, and 5 and an option to add a wing for Grade 6 at a future date; would only be 80,000 square feet; does not include funds for site acquisition, for utilities, and only modest funds for site preparation; that actual costs will not come in until later this month; and that Dr. Lewis stated that they used a contract procedure called Construction Management and Risks; and that the County will be watching with interest the development of the school in Poquoson.

5. National Association of Counties Prescription Drug Discount Program

Mr. Doug Powell, Manager of Community Services, stated that the National Association of Counties (NACo) has initiated a prescription drug discount program in which the County can participate. The Program provides discount cards to any citizen of the County regardless of age or income that can be presented to participating pharmacies to receive a discount on prescriptions that are not covered by other insurance.

Mr. Powell stated that the discounts range from 13 to 35 percent and up to 50 percent on mail order purchase, that there is no cost to the County or to the citizens to participate, and requested that the Board approve the resolution.

Mr. Bradshaw requested verification that the discount cards would be available to everyone although it would primarily benefit those without health care insurance.

Mr. Powell confirmed the statement.

Mr. Bradshaw inquired if any of the pharmacies in the County wish to participate and would they be able to contact Community Services to get information on how to do so.

Mr. Powell stated that is correct.

G. PUBLIC HEARINGS

1. <u>Design Guidelines for the Toano Community Character Area Study</u>

Mr. Jason Purse, Planner, stated that an amended resolution and an erratasheet have been provided to the Board, introduced Mr. Fred Boelt, a member of the Toano Community Character Area Study Steering Committee, and Mr. Eric Wright, Renaissance Planning Group, to give an overview of the proposed guidelines

recommended by the Toano Community Character Area Study Steering Committee and requested the Board's approval of the amended resolution.

- Mr. Boelt and Mr. Wright provided an outline of the members of the Toano Community Character Area Study Steering Committee, an overview of the history of the Toano area, the process used to develop the design guidelines, the recommendations for the design guidelines, and requested approval of the guidelines.
- Mr. Goodson inquired if the current Zoning Ordinances will need to be amended to accommodate the guidelines represented.
- Mr. Purse stated that staffdoes not expect that the Ordinance will have to be amended to accommodate the guidelines.
 - Mr. Goodson opened the Public Hearing
- 1. Ms. Terri Hudgins, 1111 Knollwood Drive, on behalf of the Stonehouse District Citizens' Association, thanked the County, the members of the steering committee, and citizens for the input and participation in the development of the guidelines.

As no one else wished to speak to this matter, Mr. Goodson closed the Public Hearing.

- Mr. Bradshaw provided an overview of the possible histories of the naming of the area "Toano," thanked those who helped with the study, and highlighted the following sentence on page 3 of the Toano Community Character Area Design Guideline & Streetscape Plan "Toano's future should be informed but not constrained by its past while enhancing its unique character."
- Mr. Bradshaw stated that the guidelines provide a pattern of redevelopment and development that will continue some characteristic of the Toano area; however the plan is conceptual and not parcel specific as a guide for private development and not a major public redevelopment of the area.
- Mr. Bradshaw commented on areas that needed clarification in the design guidelines as outlined in the errata sheet to eliminate confusion of possible conflicts with the Comprehensive Plan and potential problem of achieving this with so many little lots if each parcel is done individually.
- Mr. Bradshaw made a motion to adopt the resolution as amended and accept the changes outlined in the errata sheet.
- Mr. McGlennon thanked Mr. Bradshaw for recommended amendments; stated that achieving the goal identified in the guidelines will be challenging and additional public participation will be needed to reach this vision; in order to facilitate this type of development there will be a need for the County to play a more direct role in the development; and the Board should not shy away from the assistance to achieve this vision.
- Mr. Harrison commended the input of the community in developing and providing guidance for shaping the future of this area.

RESOLUTION

DESIGN GUIDELINES FOR THE TOANO COMMUNITY CHARACTER AREA

- WHEREAS, on September 13,2005, and October 11, 2005, the James City County Board of Supervisors created the Toano Community Character Area Study Steering Committee to conduct a comprehensive study of the area and develop a set of design guidelines for future development; and
- WHEREAS, these guidelines will be used by citizens, staff, the Planning Commission, and the Board of Supervisors to guide recommendations and decisions in future land use cases and other development activity in the Toano area; and
- WHEREAS, after five public meetings the Toano Community Character Area Study Committee (the "Committee") unanimously adopted a set of design guidelines for the area generally known as "Toano" and referred to in the Study adopted by the Committee as the "Toano Community Character Area"; and
- WHEREAS, on January 9, 2006, the James City County Planning Commission (the "Commission") unanimously recommended approval of the design guidelines set forth in the Study.
- NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of James City County, Virginia, hereby endorses the design guidelines as drafted by the Committee and recommended by the Commission, which shall be used alongside the 2003 Comprehensive Plan when reviewing rezonings, special use permits, and other development activities within the area generally known as "Toano" and referred to in the Study adopted by the Committee as the "Toano Community Character Area":

Design Guidelines for the Toano Community Character Area of James City County

The historic village of Toano sits along Route 60 in the northern part of James City County (the "County"), between Anderson's Corner and Norge. The Toano Community Character Area (the "Community Character Area") stretches from approximately the railroad tracks on the west to Bush Springs Road on the east and includes the intersection of Route 60 and Forge Road. Toano has seen a lot of change over time, particularly Route 60 has been widened through the main historic section of the town.

The growth and future development currently taking place in the Toano area prompted this study, and through these principles and guidelines, the County wishes to preserve the character and qualities that make this area unique.

The Toano Community Character Area Study Committee (the "Committee") was created by the Board of Supervisors to listen to the views of County citizens, particularly those who live and work in Toano. The Committee's purpose was to recommend principles and guidelines that highlight and honor Toano's history, encourage growth that enhances character, and improve streetscapes and a pedestrian-friendly town center. The principles and guidelines will be incorporated into the next regularly scheduled update of the County's Comprehensive Plan. Until that time, these principles and guidelines, when approved, will serve as an addendum to the 2003 Comprehensive Plan.

1. Planning Principles

- i. Highlight and honor history
- ii. Encourage appropriate growth that enhances unique small-town character
- iii. Preserve open space/rural lands; establish communal greenspace
- iv. Enhance pedestrian and bicycle environment while slowing vehicular traffic
- v. Improve streetscape and landscape to create sense of place

2. Design Guidelines Plan

The design guidelines, attached hereto as Exhibit A, highlight improvements and plans for the Toano area, and give guidance for all future developments inside the Community Character Area. The guidelines shall be considered and interpreted as conceptual and not necessarily as parcel specific.

For parcels fronting on Richmond Road with a designation of moderate density residential on the 2003 Comprehensive Plan Land Use Map, the design guidelines supplement that designation to encourage a mix of commercial and residential uses, but predominantly neighborhood commercial on the highway frontage.

3. Implementation Strategies

- i. New development and redevelopment in the Community Character Area shall implement the design guidelines.
- ii. Utilize available funds in the Capital Improvement Program budget as well as alternate sources of funding including grants or private contributions to construct sidewalks and pedestrian crosswalks in accordance with the design guidelines. Target capital investments by James City County (e.g., landscaping, underground utility lines, streetscape improvements, etc.) to support private reinvestment and redevelopment.
- iii. Utilize available State and Federal grants, including the Virginia Department of Transportation (VDOT) Transportation Enhancement Program to implement streetscape improvements.
- iv. In accordance with the recommendations of the James City County Architectural Survey establish the Toano Historic District so that property owners may qualify for redevelopment tax credits. Assist property owners in placing qualified properties on the State and Federal registers of historic places.
- v. Using the successful lamestown Corridor Enhancement Committee as a model, establish a Toano Enhancement Committee in partnership with the Friends of Forge Road and Toano and/or the Williamsburg Land Conservancy. Fund a matching grant program similar to that established for Jamestown Road.
- vi. As part of the update of the County's Community Appearance Guide, create a section providing specific examples for Toano.

vii. As part of a public sector contribution, there should be created an illustrative Master Plan for areas within the Community Character Area which have a critical need for joint development to ultimately achieve the vision of the design guidelines.

2. Case No. <u>ZO-6-05</u>. Retail Sales of Plant and Garden Supplies

Mr. Joel Almquist, Planner, stated that at the request of a citizen, staff proposes to amend two sections of the Zoning Ordinance related to retail plant and garden centers to allow retail plant and garden supply stores with a special use permit within the A-1, General Agriculture District, and to include the definition of plant and garden supply sales.

On October 27, 2005, and December 29,2005, the Planning Commission Policy Committee met to consider the question of adding retail sales of plant and garden supplies as a by-right use or a specially permitted use in the **A-I** Zoning District and review the definition of plant and garden supply sales as defined by staff.

The Planning Commission Policy Committee voted unanimously to recommend approval of the definition and accept retail plant and garden supply stores as a specially permitted use in the A-1 Zoning District.

On January 9,2006, the Planning Commission recommended approval of the ordinance amendment by a vote of 6-0.

Staff requested that the Board adopt the Zoning Ordinance amendments.

Mr. Goodson opened the Public Hearing.

As no one wished to speak to this matter, Mr. Goodson closed the Public Hearing

Mr. Bradshaw made a motion to adopt the ordinance, stated that it is well crafted, and that he hopes additional allowances will be presented in the future.

3. Budget Amendments – FY 2006

Mr. John E. McDonald, Manager of Financial and Management Services, recommended a series of budget amendments in response to the mid-year budget review of the County's revenue collections and following discussions with the Board at the Budget Retreat meeting on January 20, 2006.

Mr. McDonald recommended the following budget amendments: \$580,000 be forwarded to the Schools with a stated preference that the funds be targeted at non-recurring costs included in the FY 2007 budget request; \$1,000,000 be dedicated to construction contingency for the high school project as a priority; \$350,000 be appropriated for the purpose of initiating a design study of a stormwater utility; \$150,000 be contributed to the Jamestown 2007 Fund; and appropriation of \$3,955,000 to the PPEA at Warhill and the community sports facility.

Mr. Goodson opened the Public Hearing.

As no one wished to speak to this matter, Mr. Goodson closed the Public Hearing.

Mr. Harrison made a motion to adopt the resolution.

- WHEREAS, a mid-year budget review of expected revenues indicates that current estimates are approximately \$2.1 million more than what is now included in the FY 2006 budget; and
- WHEREAS, the August 2005 lease financing that generated \$22,630,000 for the Warhill PPEA project and the community sports facility has not been fully appropriated.
- NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of James City County, Virginia, hereby amends the previously adopted budget for the fiscal year ending June 30,2006, and appropriates the following sums in the amounts and for the purposes indicated:

H. BOARD CONSIDERATION

1. Technolow Business Incubator Management Agreement and Lease Approvals

Mr. Keith A. Taylor, Economic Development Director, stated that the County and its Economic Development Authority (EDA) want to support the development of new and emerging companies in the County through the establishment of a James City County Technology Business Incubator with the Hampton Roads Technology Council (HRTC) as the management entity for the Incubator.

At its meeting on January 19, 2006, the EDA unanimously recommended approving a proposed Management Agreement for the Incubator, which commits the EDA to provide an operating subsidy from its own funds to HRTC totaling up to \$304,000 over a five-year period, contingent upon County approval.

Mr. Taylor requested that the Board approve the resolution authorizing the County Administrator to sign the EDA-approved Management Agreement, subject to its approval by the HRTC, and to sign the proposed Lease, subject to its approval by HRTC.

Mr. Tim J. Early, Director of the Hampton Roads Technology Council, provided an overview of the proposed Incubator system that is modeled **after** one located in Florida and how the incubator would work with businesses.

Mr. McGlennon inquired what happens with firms locating within the jurisdiction it incubated, and if marketing to attract businesses is done regionally rather than for a specific jurisdiction.

Mr. Early stated that technology based businesses are a promising industry, that there are incentives for businesses to locate in a given area, and that marketing is for regional location.

TECHNOLOGY BUSINESS INCUBATOR

MANAGEMENT AGREEMENT AND LEASE APPROVALS

- WHEREAS, James City County (the "County") and its Economic Development Authority (the "EDA") wish to support the development of new and emerging companies in the County through the establishment of a James City County Technology Business Incubator (the "Incubator"); and
- WHEREAS, staff of the Office of Economic Development (the "OED) has recommended an implementation strategy for creating and operating the Incubator; and
- WHEREAS, the Hampton Roads Technology Council (the "HRTC") has a proven track record of operating technology incubators in the Hampton Roads region; and
- WHEREAS, both the OED and the EDA propose HRTC as the management entity for the Incubator; and
- WHEREAS, previously appropriated Capital Improvement Funds are available to the OED to cover the cost of furnishing and equipping the Incubator; and
- WHEREAS, at its January 19,2006, meeting, the EDA unanimously passed a motion approving a proposed Management Agreement for the Incubator, which commits the EDA to provide an operating subsidy from its own funds to HRTC totaling up to \$304,000 over a five-year period, said approval being contingent upon County approval; and
- WHEREAS, the County's approval of a lease between the County and HRTC for one floor of office space located at Ironbound Village and further identified as 5300 Palmer Lane, Suite 2 (the "Lease") will provide the physical space necessary to house the Incubator.
- NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of James City County, Virginia, hereby:
 - 1. Authorizes the County Administrator to sign the EDA-approved Management Agreement, subject to its approval by the HRTC, and
 - 2. Authorizes the County Administrator to sign the proposed Lease, subject to its approval by HRTC.



AN ORDINANCE TO AMEND AND REORDAIN CHAPTER 24, ZONING, OF THE CODE OF THE COUNTY OF JAMES CITY, VIRGINIA, BY AMENDING ARTICLE I, IN GENERAL, SECTION 24-2, DEFINITIONS; AND ARTICLE V, DISTRICTS, DIVISION 2, GENERAL AGRICULTURAL DISTRICT A-1, SECTION 24-213, USES PERMITTED BY SPECIAL USE PERMIT ONLY.

BE IT ORDAINED by the Board of Supervisors of the County of James City, Virginia, that Chapter 23, Zoning, is hereby amended and reordained by amending Section 24-2, Definitions; and Section 24-213, Uses permitted by special use permit only.

Chapter 24. Zoning Article I. In General

Section 24-2. Definitions.

For the purposes of this chapter, the following words and phrases shall have the meaning respectively ascribed to them by this section:

Plant and garden supply sales. Stores which shall sell a combination of materials used in the process of creating, cultivating, decorating, and maintaining gardens and landscaped areas. The primary items sold may include plants, shrubs, and trees grown on- or off-site; seeds; produce; hand tools; fertilizer; plant containers and hangers; natural materials such as sand, soil, rock, wood chips, and mulch; and decorative features including sculptures, fountains, ponds, ornaments, and cast or formed cement and ceramic pavers. Patio and outdoor furniture, including grills, gazebos, trellises, and outdoor fireplaces may also be included as secondary and incidental items sold at a plant and garden supply store. Excluded from this definition are mechanical lawn and garden equipment, pools and pool equipment, lumber and building supplies.

Article V. Districts

Division 2. General Agricultural District, A-1

Section 24-213. Uses permitted by special use permit only.

In the General Agricultural District, A-I, buildings to be erected or land to be used for the following uses shall be permitted only after the issuance of a special use permit approved by the board of supervisors in accordance with the procedures, guides and standards of sections 24-9 and 24-10 and other such guides and standards as may be contained in this chapter.

Retail sales of plant and garden supplies.
