Regular Meeting of Tuesday June 13, 2023 1st Floor Conference Room JCC Office of Elections, 4095 Ironbound Rd, Williamsburg, Virginia

1. Call to Order- Dot Matthews, Chair, called the meeting to order at 10:02 am. Others attending were Perry DePue, Vice Chair; Curtis Stoldt, Secretary; Dianna Moorman, Director of JCC Elections/General Registrar; Shiela Lohr, Deputy Director of JCC Elections. No public in attendance.

2. **Approval of Minutes-**. Dot Matthews moved to approve the minutes from the May 9, 2023 as written and presented to the board. Perry DePue seconded the motion. Vote: 3 Yay and 0 nay.

3. Director of Elections/GR Monthly Report:

a. 2nd floor construction going well and on schedule for moving into the new space on June 22 and June 23.

b. Staffing and Space Report- Staffing and Space requirements are status quo. Staff in-service training is ongoing. The "Stop the Bleed- Active Threat Training" was well received by the staff on 17 May 2023. GR continues to work with JCC to add an additional fulltime position and to add a fulltime person to work the from desk to interact with the public efficiently and maintain continued confidence in the JCC Election Office.

c. Law Changes- This is a work in progress at ELECT. The new laws go into effect on July 1, 2023. New Election Code books will be printed in July and further discussion of the new laws will occur in July/August after ELECT provides a summary of the new laws and advisement on their implementation.

d. Report and Discussion on New Election Reporting System - The new Election Reporting System is in the final stages of development at ELECT and will be implemented for the November General Election. Further direction from ELECT is pending.

e. 2023 General Election Update- The office is well ahead of schedule in preparation for the 2023 General Election in November. The goal date to be completely ready for the General Election is Sept 1. JCC Election Office is well ahead of this goal.

f. General Registrar/Director of Elections Certification Requirements- Dianna is completing CERA training with a conference in Milwaukee, WI. She will then graduate from the Auburn University sponsored CERA training in August. She is on schedule and will likely complete the required certification well ahead of schedule.

g. Other Business- None

The motion to certify the closed session was seconded by Chair Matthews and passed by a unanimous vote of the board, 3 yea 0 nay.

8. Appointment of General Registrar pursuant to Section 24.2-110 of the Code of Virginia
