2. Director of Elections/General Registrar's Monthly Report

- June Primary
 - o As of 40 minutes ago, 163 voters have voted.
 - Approximately 200 Absentee Ballots have been returned to date. 2,707
 Absentee Ballots have been issued.
 - There will not be a Chiefs Roundtable after the June Primary. Ms. Moorman has
 discussed this with the Chiefs and everyone agrees with this decision.
- Canvass
 - Canvass will begin at 11 AM on Wednesday, June 18.
 - The Provisional Hearing will begin on Wednesday, June 18, at 1:30 and is open to an observer from the Democratic Party only.
 - Certification must be finished by Monday, June 23.
- November Election
 - John Curren is planning to have a "write-in" campaign for Republican Lt.
 Governor.
 - Ms. Matthews listened to the audio on the accessible voting device during L&A
 Testing and found it to be very clear.
- OFFFICIAL Results The only OFFICIAL results of an election are on the State Board of Elections website. Worksheets with Results of James City County Elections only will be labeled "UNOFFICIAL Results Worksheet."
- Flagpole The Flagpole next to the building has been installed. A 4' x 6' US flag and a 3' x 5' VA flag will be on the flagpole.
- **3. Public Comment** Two people spoke during the public comment period.

- New Election Officers Ms. Matthews moved we approve the new Election Officers as presented on the list of 2025-2027 Election Officers. Ms. Cheves seconded the motion that was approved by unanimous vote.
