JAMES CITY COUNTY ELECTORAL BOARD MEETING June Democratic Primary Election Canvass

<u>Wednesday, June 18</u> - The James City County Electoral Board (EB) met on Wednesday, June 18, 2025, to begin a Canvass of the results of the Democratic Party Primary Election held on Tuesday, June 17, 2025. The Canvass was carried out in accordance with Virginia law and election policy. Present were Dot Matthews, Chair; Dr. Curtis Stoldt, Vice Chair; Kay Cheves, Secretary; Dianna Moorman, Director of Elections/General Registrar; and the Chief Deputy Coordinator. The meeting was called to order at 11 a.m. The main business of the Board was a Canvass of the precincts located throughout James City County. The EB recessed for lunch at 12:20.

The Board reconvened and went into Closed Session at 1:30 p.m. for the Provisional Hearing to allow voters casting provisional ballots to present information regarding their qualifications to vote in the precinct where they cast their provisional ballot. Two provisional voters were present; the Provisional Hearing was closed at 1:34 p.m. and the EB went into open session.

At 1:36 p.m. Dr. Stoldt moved the Board go into Closed Session for the purpose of considering whether each person who cast a provisional ballot was qualitied to do so. Ms. Cheves seconded the motion which passed by unanimous vote. The Board finished consideration of provisional ballots at 1:55 p.m. Ms. Matthews moved that the James City Electoral Board certify that the only matters discussed in the Closed Session were the qualifications of provisional voters, as permitted by Virginia Code 24.2-653. Dr. Stoldt seconded the motion that passed unanimously.

Ms. Matthews moved the EB tentatively accept the yes (24) and no (1) votes for the provisional ballots. Dr. Stoldt seconded the motion that passed with a unanimous vote. The Board recessed at 2:04 p.m. until Friday, June 20, 2025, at 11:00 a.m.

<u>Friday, June 20</u> - The EB reconvened the Canvass at 11:02 a.m. to continue the Canvass. Present were Ms. Matthews, Dr. Stoldt, Ms. Cheves, Ms. Moorman, and the Chief Deputy Coordinator. At 11:39 a.m. Dr. Stoldt moved we recess until Monday, June 23, at 1:00 p.m.

Monday, June 23 — The EB reconvened the Canvass at 1:02 p.m. Present were Ms. Matthews, Dr. Stoldt, Ms. Cheves, Ms. Moorman, and the Chief Deputy Coordinator. With the final results in hand, the Director of Elections/General Registrar and JCC Office of Elections staff produced the final set of abstracts to file with the Virginia Board of Elections. After checking the abstracts to make sure the numbers included the tentatively approved provisional ballots and were consistent with the final results, EB members signed the abstracts, completing the Canvass process. At 2:05 p.m., Dr. Stoldt moved the meeting be adjourned. Ms. Matthews seconded the motion that was approved unanimously.

<u>Next Meeting</u>: The EB will not meet in July. The EB agreed to change the August meeting date from August 12 to Tuesday, August 19, at 10 a.m.
