## D. ACTION ITEMS

## 1. <u>Certificate of Deposit</u>

Mr. Seymour briefed the EDA on the financial situation of the EDA and the cost of the Incubator build-out. He clarified that cashing out the Certificate of Deposit (CD) will cover the remaining cost of the build-out and fund the EDA's operating expenses for the rest of the fiscal year.

Mr. Gerhardt clarified how many CDs are being cashed out. The resolution references three.

Mr. Seymour stated that one is needed right now and will be cashed out with the EDA's authorization. The other two referenced in the resolution would only be cashed out if necessary as was discussed in Closed Session.

Mr. Tingle stated that the resolution does not read that way. It should be amended to state that one CD is being cashed out with the option to cash out the other two if necessary or needed or something similar.

Ms. Gowdy stated that the resolution could be modified to state that "the EDA desires to authorize the Director of Economic Development to cash in those three certificates of deposit, if needed, and transfer those funds to the EDA's checking account for future use as needed."

Mr. Gerhardt made a motion to approve the resolution with the amended language proposed, which Mr. Tingle seconded.

The motion passed by a unanimous voice vote.

# 2. Mutual Cooperation Agreement between EDA and Board of Supervisors

Mr. Montgomery made a motion to approve the resolution that was presented in Closed Session by Ms. Gowdy and to allow any last minute changes or revisions as the Chairman approves, which was seconded by Mr. Tingle.
