Mr. Tingle made a motion to authorize the chairman to enter into an option agreement for a period up to 20 years with James City County and in regard to the Jamestown Marina, which was seconded by Ms. Carson.

Ms. Gowdy stated that the draft language for the RFP could be brought back to the EDA for approval at its meeting on December 10, 2015.

The EDA voiced its approval.

The EDA generally discussed the closing date of the RFP and decided to close it on January 8, 2016, which would allow proposals to be brought before the EDA at its regular meeting in January.

Mr. Gerhardt requested to have the names of solicitations be sent to the EDA when the RFP closes so that any conflicts of interest may be determined prior to the meeting.

Ms. Gowdy stated that it should not be a problem to release just the names on January 8. The discussion of the proposals would need to be done in Closed Session at the meeting on January 14.
