Mr. Hlavin introduced a resolution addressing the fact that the meeting was being held in an electronic format pursuant to the continuity of government ordinance adopted by the Board of Supervisors due to social distancing guidelines issued in response to the COVID-19 outbreak.

Mr. Wiggins presented the revenue and expense reports for January 2020, February 2020, and March 2020.

1. Enter Closed Session

A motion to enter Closed Session was made by William Turner; motion Passed. AYES: 6 NAYS: 0 ABSTAIN: 0 ABSENT: 0 Ayes: Campana, Meredith, Stanko, Stockton, Tingle, Turner

Mr. Turner moved to go into Closed Session in accordance with the Code of Virginia for the purposes of: 1) discussion concerning a prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the interest in locating or expanding its facilities in the community pursuant to Va. Code Section 2.2-3711(A)(5); and 2) the investment of public funds to incentivize relocating or expanding companies where competition or bargaining is involved where, if made public initially, the financial interest of the Authority and the County would be adversely affected pursuant to Va. Code Section 2.2-3711(A)(6); and 3) discussion or consideration of the disposition of publicly held real property located at 8925 Columbia Drive, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the Authority pursuant to Va. Code Section 2.2-3711(A)(3); and 4) discussion or consideration of proprietary information related to economic development, voluntarily provided by private business pursuant to a promise of confidentiality from the Authority and used for business development and retention pursuant to Va. Code Section 2.2-3711(A)(39); and 5) consultation with legal counsel retained by the Authority regarding specific legal matters related to agreements and property owned by the Authority requiring the provision of legal advice by such counsel pursuant to Va. Code Section 2.2-3711(A)(8).

#### G. NEW BUSINESS

#### 1. Marina Property

A motion to enter into a supplemental agreement with Billsburg Brewery was made by Vince Campana; motion Passed. AYES: 6 NAYS: 0 ABSTAIN: 0 ABSENT: 0

Ayes: Campana, Meredith, Stanko, Stockton, Tingle, Turner

As a result of discussion in Closed Session and at the request of Billsburg Brewery, the tenant at the Marina property managed by the EDA, Mr. Campana presented a motion to enter into a supplemental agreement with Billsburg Brewery due to the COVID-19 outbreak and unforeseen interruptions in business activity. Mr. Campana's motion included rent abatement for the month of April 2020, as well as rent deferral for May, June, and July 2020 to be repaid over a 12-month period, with the understanding that Billsburg Brewery will pursue additional financial relief from other local, state, and/or federal programs and share financial information with the EDA upon request in order to elucidate the financial realities of the COVID-19 outbreak. Finally, Mr. Campana's motion included the ability of the EDA Chair to work with EDA Counsel to finalize said agreement in accordance with these provisions.

#### 2. Draft Budget-Fiscal Year 21

Ms. Sipes presented a draft EDA budget for the upcoming fiscal year, based upon discussions with Mr. Wiggins and Mr. Stockton. Ms. Sipes noted the revenue estimates were provided by Mr. Wiggins. Ms. Sipes further noted the intention to remove the bank balance from the budget and return to a more conventional format; using this format the budget was prepared with the intent to minimize expenditures. Ms. Sipes further noted the expense line items with significant changes from the current year include the James River Commerce Center, Business Assistance, Annual Audit, and Office Supplies. The Annual Audit line item was increased, based on the estimated cost provided by Mr. Wiggins; all other expense line items changed were reduced to cover known financial obligations only; and remove additional funds for unforeseen expenses. Ms. Sipes noted any additional expenses could be accommodated with a vote to amend the budget as needed and with input of the full EDA.

Mr. Tingle noted his preference for the new format without the bank balance, but requested a monthly reporting of the bank balance for accountability and transparency.

Ms. Sipes replied she can work with Mr. Wiggins to have that information available at each monthly meeting and reflected in the minutes.

Ms. Meredith noted the draft budget would require a modification in light of the action taken with regard to Billsburg Brewery.

Ms. Sipes agreed to make the necessary modifications and bring the draft budget to the May meeting for adoption.

### 3. Virginia 30 Day Fund

A motion to approve a contribution in the amount of \$3,333.33 from the EDA's Business Assistance line item to Greater Williamsburg Partnership for the Virginia 30-Day Fund was made by Tom Tingle; motion Passed. AYES: 6 NAYS: 0 ABSTAIN: 0 ABSENT: 0 Ayes: Campana, Meredith, Stanko, Stockton, Tingle, Turner

Mr. Johnson presented an opportunity that was identified in the previous few days to collaborate with the Greater Williamsburg Partnership (GWP), the Williamsburg Community Foundation (WCF) and the Virginia 30-Day Fund (VA 30-Day Fund). Mr. Johnson explained the VA 30-Day Fund is a statewide 501(c)3 that has created grants in the amount of \$3,000 to Virginia businesses. Mr. Johnson noted the VA 30-Day Fund was created by Pete Snyder, an alumnus of the College of William & Mary. Mr. Johnson shared that the GWP has been communicating with Mr. Snyder and has determined that dollars contributed could be allocated for grants to businesses in the Greater Williamsburg localities. Mr. Johnson further explained the WCF can accept contributions from local public and private sources and give those funds to the VA 30-Day Fund, a 501(c)3 organization, for the specific purpose of funding grants to Greater Williamsburg businesses.

Mr. Johnson presented the proposal by the GWP to the EDAs of James City County, York County, and the City of Williamsburg to jointly contribute \$10,000 (\$3,333.33 from each locality) to the GWP for the purpose of creating a grant program with the VA 30-Day Fund, in partnership with the WCF, for businesses located in Greater Williamsburg. Mr. Johnson explained the \$10,000 contribution can in turn leverage contributions from other public or private entities willing and able to provide funds through the WCF to the VA 30-Day Fund and eventually to businesses in James City, York County, and the City of Williamsburg adversely affected by the COVID-19 closures.

Mr. Johnson concluded by proposing the EDA support this initiative from the Business Assistance line item in the Fiscal Year 20 budget, noting the balance of \$5,000. Mr. Johnson reminded the EDA of its action to approve \$2,000 for a regional effort in The Edge District at a previous EDA meeting, and that money had not yet been invoiced or paid.

Mr. Tingle asked if that project was proceeding on schedule.

Mr. Johnson responded that he was uncertain if the specific marketing efforts had proceeded, but was under the impression that other funding had been identified and the EDA's \$2,000 would likely not be needed.

Mr. Tingle indicated his support of partnering with GWP and WCF, noting the relative small amount of money could encourage other organizations or individuals to contribute.

Ms. Meredith noted her agreement.

# ECONOMIC DEVELOPMENT AUTHORITY ELECTRONIC MEETING HELD APRIL 21, 2020

- WHEREAS, on March 24, 2020 the James City County Board of Supervisors (the "Board") adopted an emergency Ordinance to ensure the continuity of government in response to the coronavirus pandemic negatively affecting the health, safety, and welfare of the citizens of James City County (the "County"); and

- WHEREAS, each of the members of the James City County Economic Development Authority have reviewed each the items listed on the Agenda and have determined that consideration of each is necessary to ensure the continuation of the essential functions of the government during the emergency described in the Ordinance.
- NOW, THEREFORE, BE IT RESOLVED that the Economic Development Authority of James City County, Virginia, hereby finds and declares that immediate consideration of each of the items set forth in the Agenda is necessary to ensure the continuation of essential functions of the government during the emergency declared by the Board and further described in the Ordinance.
