ORDINANCE NO. 66A-80

ORDINANCE TO PERMIT USE OF GOLF CARTS ON

PUBLIC HIGHWAYS IN WINDSOR FOREST

WHEREAS, the residents of Windsor Forest have petitioned the Board of Supervisors of James City County, Virginia, to designate the streets in Windsor Forest for golf cart use; and


WHEREAS, the Board has carefully considered the concerns voiced by the residents of Windsor Forest, the recommendation of staff, and the speed, volume, and character of motor vehicle traffic using the public highways in Windsor Forest; and

WHEREAS, pursuant to Section 46.2-916.2 et seq. of the Code of Virginia and Section 13-60 et seq. of the County Code, the Board has determined that golf cart operation on the public highways in Windsor Forest is compatible with state and local transportation plans and is consistent with the Commonwealth of Virginia's Statewide Pedestrian Policy.

NOW, THEREFORE, BE IT ORDAINED that the Board of Supervisors of James City County, Virginia, does hereby designate the following roads located in the Windsor Forest neighborhood for golf cart use:
