### D. PUBLIC HEARINGS

1. WJPA 19-0012 / VMRC 19-0364 : 4029 South Riverside Drive

Watershed Planner, Mr. Trevor Long, presented the permit request submitted by Ms. Karla S. Havens, Mid-Atlantic Resource Consulting, on behalf of Mr. Mark and Mrs. Lisa Hill, who have applied for a wetlands permit to construct a bulkhead located at 4029 South Riverside Drive, within the Chickahominy Haven Subdivision and the Yarmouth Creek watershed. The property is further identified as James City County Parcel No. 1910300005. The presentation described the current site conditions, proposed construction, and proposed mitigation. Staff recommended approval of the permit withconditions.

The Board deliberated the pros and cons of this permit.

#### 2. WJPA 19-0021 / VMRC 19-0516 : 2711 Jolly Pond Road

Senior Watershed Planner, Mr. Michael Woolson, presented the permit request submitted by Ms. Karla S. Havens, Mid-Atlantic Resource Consulting, on behalf of Mr. David and Mrs. Tonya Pegram, who have applied for a wetlands permit to construct a pier over vegetated tidal wetlands located at 2711 Jolly Pond Road and the Gordon Creek watershed. The property is further identified as James City County Parcel No. 3520100015C. The presentation described the current site conditions, proposed construction and proposed mitigation. Staff recommended approval of the permit with conditions.

The Board deliberated the pros and cons of this permit.

Mr. Apperson opened the Public Hearing.

## E. BOARD CONSIDERATIONS

### 1. WJPA 18-0089 / VMRC 18-0211 : 209 Sherwood Forest

Mr. Woolson presented the extension request for the permit obtained by Mr. Henry Thorndike, Dock Masters Marine Construction, on behalf of Mr. John F. Cox. The permit was originally issued on April 11, 2018, for a period of one year. The permit was to replace an existing pier using an excavator on timber mats on the property located at 209 Sherwood Forest within the Riverview Plantation subdivision and the York River watershed. The property is further identified as James City County Parcel No. 1730200007. Staff is agreeable with the extension with the stipulation that all previous conditions are incorporated into the extension approval. The Board deliberated the pros and cons of the extension request.

Mr. Roadley made a motion to grant the permit extension for Wetlands Board Case No. WJPA 18 -0089 / VMRC 18 -0211 at 209 Sherwood Forest.

A motion to Approve w/Conditions was made by Mr. Roadley, the motion result was approved 5-0 with one absent.
